the local education authority may in their discretion grant in respect of that pupil a special allowance (in these Regulations referred to as a boarding allowance) of such value as the authority may with the approval of the Ministry determine."

The Ministry of Education in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations.

- These Regulations may be cited as the Grammar School (Grant Conditions) Amending Regulations, 1952.
- 2. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations, 1948 (a), as amended by the Grammar School (Grant Conditions) Amending Regulations, 1949 (b), 1950 (c) and 1951 (d).
- 3. Paragraph 2 of the Third Schedule to the existing Regulations which, as amended by the Grammar School (Grant Conditions) Amending Regulations No. 2, 1951, provides for the payment of salary grant, shall have effect as if for the figure " £300" in the aforesaid paragraph there were substituted "£340 in the case of a man and 1332 in the case of a woman ".

This Regulation shall come into operation on the first day of July, 1952, and shall not apply to the salary payable in respect of service rendered by any teacher before that date.

REGULATIONS, DATED 24TH JULY, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 to 1952, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1952. No. 146

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations.

- 1. These Regulations may be cited as the Grammar School (Grant Conditions) Amending Regulations No. 2, 1952.
- 2. These Regulations shall come into operation on the first day of August, 1952.
- 3. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations, 1948 (a), as amended by the Grammar School (Grant Conditions) Amending Regulations, 1949 (b), 1950 (c), 1951 (d), and 1952 (e).
- 4. For Regulation 8 of the existing Regulations, as amended by the Grammar School (Grant Conditions) Amending Regulations, 1950, there shall be substituted the following:—
 - "8. The time-table shall provide that the school shall be open during the school year for at least 192 days (exclusive of Sundays) of which not more than five days may be counted in any one calendar week from Sunday to Saturday inclusive:

Provided that -

- (a) the requirement of 192 days may for any school year be reduced to 187 days in the case of a school at which, in the preceding school year, the number of boarders in the secondary department was at least (i) 150 and (ii) half the number of pupils on the roll in that department;
- (b) the Ministry may in exceptional circumstances permit variations from the approved time-table upon application made to the Ministry by the principal or other approved authority of the school."
- 5. Paragraph (2) of Regulation 11 of the existing Regulations is hereby revoked.
