Hospital Management Scheme

Special Care Service

Order, dated 14th February, 1952, made by the Ministry of Health and Local Government under the Health Services Act (Northern Ireland), 1948.

1952. No. 14

WHEREAS, by Order (a) dated the eleventh day of April, One thousand nine hundred and fifty-one made under section twenty-eight of the Health Services Act (Northern Ireland), 1948 (in this Order referred to as "the Act"), the Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry") approved a new general scheme submitted by the Northern Ireland Hospitals Authority (in this Order referred to as "the Authority") providing for the management and control of the institutions set out in the Schedule to the said scheme and for the appointment of a management committee to be known as the Special Care Service Management Committee :

AND WHEREAS it is provided under section twenty-nine of the Act that it shall be the duty of the Authority to submit to the Ministry a scheme or schemes making provision for the performance by each management committee of such functions as the Authority, after consultation with the management committee concerned, consider necessary for the local control and management of each hospital or group of hospitals, as the case may be, through which hospital and specialist services are to be provided under the Act :

AND WHEREAS the Authority, on the twenty-eighth day of June, One thousand nine hundred and fifty-one, submitted to the Ministry the Special Care Service Management Scheme :

AND WHEREAS it is provided under sub-section (3) of section twentynine of the Act, that the Ministry may approve a management scheme under that section with or without modifications :

AND WHEREAS the Ministry thinks fit to approve of the Special Care Service Management Scheme subject to the modification hereinafter specified :

Now THEREFORE, the Ministry in exercise of the powers conferred upon it by the Act, hereby orders as follows :----

1.—(1) This Order may be cited as the Health Services (Approval of the Special Care Service Management Scheme) Order (Northern

Ireland), 1952, and shall be deemed to have had effect from the twentythird day of October, One thousand nine hundred and fifty-one.

(2) The Interpretation Act, 1921, shall apply for the purposes of the interpretation of this Order in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. The Ministry hereby approves of the Special Care Service Management Scheme dated the twenty-eighth day of June, One thousand nine hundred and fifty-one subject to the deletion of the words "and he shall be the principal administrative officer acting under the directions of the Management Committee" in sub-paragraph (iii) of paragraph four thereof and directs that a copy of this Order and a copy of the Special Care Service Management Scheme shall be available at each of the institutions under the management and control of the Special Care Service Management Committee for inspection by members of the public at all reasonable times.

REGULATIONS, DATED 24TH SEPTEMBER, 1952, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT, WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER THE HEALTH SERVICES ACT (NOR-THERN IRELAND), 1948.

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by sections twenty-one and seventy-six of the Health Services Act (Northern Ireland), 1948, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following regulations :---

1.—(1) These Regulations may be cited as the Health Services (Remission of Charges for Dentures) (Hospitals) Regulations (Northern Ireland), 1952, and shall come into operation on the first day of October, 1952.

(2) Any reference in these Regulations to any enactment shall be construed as a reference to that enactment as amended by or under any subsequent enactment.
