- 2. Interest shall be added after the tenth anniversary of the date of purchase and up to and including the twenty-second anniversary of that date at the rate of one penny in respect of each unit certificate of the Supplementary Issue for each completed period of three months.
- 3. For the purposes of this direction a multiple certificate shall be taken to be such number of unit certificates as is represented by that multiple certificate.

- 1. This Order may be cited as the Factories (Forms and Particulars) Order (Northern Ireland), 1952.
- 2. The Interpretation Act, 1889 (c) applies to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 3. The Notice of exceptional overtime in fruit or vegetable preserving factories which is required under Regulation 6 of the Factories (Fruit and Vegetable Preserving—Hours of Women and Young Persons) Regulations (Northern Ireland), 1946 (d) shall be in the form N.I.29, set out in the Schedule to this Order.
- 4. The register of women and young persons which is required to be kept by Regulation 7 of the Factories (Fruit and Vegetable Preserving—Hours of Women and Young Persons) Regulations (Northern Ireland), 1946 (d), shall be in the form N.I. 40, set out in the Schedule to this Order.

Conditions for Increase of Allowance

REGULATIONS, DATED 26TH AUGUST, 1952, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE FAMILY ALLOWANCES ACTS (NORTHERN IRELAND), 1945 AND 1952.

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance so far as relates to matters with respect to which the Ministry of Finance has so directed, in exercise of the powers conferred on it by sub-section (7) of section 21 of the Family Allowances Act (Northern Ireland), 1945 (a), and sub-section (1) of section 9 of the Family Allowances and National Insurance Act (Northern Ireland), 1952 (b), and of all other powers enabling it on that behalf, hereby makes the following regulations:—

Citation, interpretation and commencement

- 1.—(1) These regulations may be cited as the Family Allowances (Conditions for Increase of Allowance) Regulations (Northern Ireland), 1952, and shall come into operation on the 2nd September, 1952.
 - (2) In these regulations unless the context otherwise requires— "the principal Act" means the Family Allowances Act (Northern Ireland), 1945;
 - "the Act of 1952" means the Family Allowances and National Insurance Act (Northern Ireland), 1952;
