

1. These Regulations may be cited as the Primary Schools (Salaries and Allowances) Amending Regulations (Northern Ireland), 1952.

2. The existing Regulations hereby amended are the Primary Schools (Salaries and Allowances) Regulations (Northern Ireland), 1951 (a).

3. The rates of salary prescribed in Regulations 4 and 5 of the existing Regulations shall be increased by £40 per annum in the case of men and by £32 per annum in the case of women in respect of service given on and after the 1st July, 1952.

### Salaries of Teachers (Special Provisions)

REGULATIONS, DATED 29TH AUGUST, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1952 AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Section 4 of the Education (Miscellaneous Provisions) Act (Northern Ireland), 1952, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Salaries of Teachers (Special Provisions) Regulations, 1952.

2. In these Regulations, unless the contrary intention appears.—  
"the principal regulations" means—

- (a) where a teacher is employed in a primary school, a nursery school or a special school, the Primary Schools (Salaries and Allowances) Regulations (Northern Ireland), 1951 (b);
- (b) where a teacher is employed in an intermediate school, the Intermediate School (Salaries and Allowances of Teachers) Regulations, 1951 (c);
- (c) where a teacher is employed in a grammar school, the Grammar School (Salaries and Allowances of Teachers) Regulations, 1951 (d);

(d) where a teacher is employed in an institution of further education, the Institutions of Further Education (Salaries and Allowances of Teachers) Regulations, 1951 (a).

“ allowance ” includes an allowance granted to a teacher —

- (i) under the principal regulations ; or
- (ii) under any regulations revoked by the principal regulations ;  
or
- (iii) where that teacher has, after 31st March, 1948, been employed in more than one type of school or institution, under any regulation prescribing rates of salaries and allowances applicable to that teacher after that date ;

in respect of a university degree (or other qualification adjudged by the Ministry to be equivalent thereto) which is recognised by the Ministry for teaching purposes but which has not been obtained as a result of full-time attendance at an approved university or college.

3. These Regulations apply to a teacher entitled to receive an allowance who has not elected to relinquish that allowance.

4. Notwithstanding the provisions of the principal regulations a teacher to whom these Regulations apply may, before such date as the Ministry may determine —

- (a) elect to relinquish the allowance to which he is entitled ; and
- (b) undertake to pay to the Ministry, within such time and in such manner as the Ministry may direct, an amount equal to the total amount of the allowances received by him in respect of the period after 31st March, 1948 ;

and thereupon the provisions of the principal regulations shall apply to that teacher as if he had elected to relinquish the allowance to which he is entitled with effect from 1st April, 1948, or from the date on which he first became entitled to that allowance, whichever is the later.

5. Where a teacher has, in accordance with Regulation 4 of these Regulations, undertaken to repay the amount of any allowance, the salary of that teacher shall, as from 1st April, 1948, or from the date on which he first became entitled to the allowance, whichever is the later, be deemed for the purposes of any regulation of the Ministry to have been reduced by the amount of that allowance.

6. The Ministry may deduct the whole or any part of the amount referred to in paragraph (b) of Regulation 4 of these Regulations from :—

- (i) the salary of a teacher paid by the Ministry ;
- (ii) any grant paid by the Ministry to the school authority by whom a teacher is paid ;

- (iii) any payment or benefit payable to a teacher or his legal personal representatives under the Teachers (Superannuation) Act (Northern Ireland), 1950.

7.—(1) The Interpretation Act, 1889, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament of Northern Ireland.

(2) If any question arises as to the interpretation of these Regulations, or as to whether any of the requirements thereof are fulfilled or as to the amount of salary payable thereunder, the decision of the Ministry shall be final.

### Trade Scholarships

REGULATIONS, DATED 30th July, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1952. No. 138

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 77 and 112 of the Education Act (Northern Ireland), 1947, (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Trade Scholarships Regulations (Northern Ireland), 1952, and shall come into operation on the date hereof.

(2) The Trade Scholarships Regulations, 1943, and the Trade Scholarships (Amendment) Regulations (Northern Ireland), 1949, are hereby revoked.

2.—(1) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them, that is to say:—

"Approved" means approved by the Ministry;

"Recognised" means recognised by the Ministry;

"Candidate" means an applicant for the award of a scholarship under these Regulations;

"Scholar" means a person to whom a scholarship is awarded under these Regulations;

"College" means any place of education approved by the Ministry for the purpose of these Regulations.
