General Dental Services

REGULATIONS, DATED 21ST FEBRUARY, 1952, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

1952. No. 17

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by Section 11 of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations:—

- These Regulations may be cited as the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland), 1952.
 - 2.—(1) In these Regulations,
 - "the Principal Regulations" means the Health Services (General Dental Services) Regulations (Northern Ireland), 1948 (a), as amended by the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland) 1949 (b), the Health Services (General Dental Services) (Amendment) (No. 2) Regulations (Northern Ireland), 1949 (c), the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland), 1951 (d), the Health Services (General Dental Services) (Amendment) (No. 2) Regulations (Northern Ireland), 1951 (e), and the Health Services (General Dental Services) (Amendment) (No. 3) Regulations (Northern Ireland), 1951 (f):

- "the Fees Regulations" means the Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948 (a), as amended by the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland), 1949, the Health Services (General Dental Services) (Amendment) (No. 2) Regulations (Northern Ireland), 1949, and the Health Services (General Dental Services—Fees) (Amendment) Regulations (Northern Ireland), 1950 (b).
- (2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- The Principal Regulations shall be amended in manner following:---
- (1) In paragraph (1) of Regulation 2 after the definition of "health centre" there shall be inserted the following definition:
 - medical card" has the same meaning as that assigned to it in paragraph (1) of Regulation 2 of the Health Services (General Medical and Pharmaceutical Services) Regulations (Northern Ireland), 1948 (c).
- (2) For Regulation 7 there shall be substituted the following Regulation :—
 - "7. Any person ordinarily resident in Northern Ireland or Great Britain, or being a person to whom the provisions of the Health Services (Availability of Services) Regulations (Northern Ireland), 1950 (d) apply, requiring general dental services may apply to a dentist whose name appears on the dental list. The person shall produce his medical card to the dentist and shall complete Part I of the dental estimate form together with such declarations relating to eligibility for (a) general dental services or (b) general dental services without charge as may be required by the Board ".
- (3) Sub-paragraph (5) of paragraph 7 of the First Schedule shall be amended by the insertion of the word "consequential" immediately before the words "provision of dentures".
- (4) At the end of paragraph 11 of the First Schedule there shall be added the following sub-paragraph:—
 - "(8) For the purpose of treating a patient for the arrest of bleeding a dentist may, instead of providing this treatment personally, make arrangements with a medical practitioner to provide such treatment on his behalf."
- (5) In the Third Schedule, after the items "Tabella Acidi Ascorbici B.P." and "Tabella Acidi Nicotinici B.P." the words "50 mg" shall be deleted.

- 4. The Fees Regulations shall be amended in manner following:—
- (1) The first item in the Scale of Fees contained in Part I of the Schedule to the Regulations shall be amended and shall read as follows:—
 - "1. Clinical examination and report
- 5s. 0d.—but not chargeable:—
- (a) for an examination in respect of repairs of dentures for edentulous patients;
- (b) where a modified estimate form is used;
- (c) for an examination of a person over 21 years of age if the dentist has been paid, or is entitled to be paid for an examination of that person made within the preceding six months; or
- (d) for an examination of a person under 21 years of age if the dentist has been paid, or is entitled to be paid for an examination of that person made since the 1st March, the 1st July, or the 1st November, whichever of those dates last occurred"
- (2) Item 24 in the Scale of Fees contained in Part I of the Schedule to the Regulations shall be amended and shall read as follows:—

"24*. Fee for any other treatment not included in this scale which is clinically necessary and is not special treatment not clinically necessary provided or supplied under Part V of the Health Services (General Dental Services). Regulations (Northern Ireland), 1948.

Such fee as the Dental Estimates Committee may approve."
