## Conditions for Increase of Allowance

REGULATIONS, DATED 26TH AUGUST, 1952, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE FAMILY ALLOWANCES ACTS (NORTHERN IRELAND), 1945 AND 1952.

### 1952. No. 171

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance so far as relates to matters with respect to which the Ministry of Finance has so directed, in exercise of the powers conferred on it by sub-section (7) of section 21 of the Family Allowances Act (Northern Ireland), 1945 (a), and sub-section (1) of section 9 of the Family Allowances and National Insurance Act (Northern Ireland), 1952 (b), and of all other powers enabling it on that behalf, hereby makes the following regulations:—

# Citation, interpretation and commencement

- 1.—(1) These regulations may be cited as the Family Allowances (Conditions for Increase of Allowance) Regulations (Northern Ireland), 1952, and shall come into operation on the 2nd September, 1952.
  - (2) In these regulations unless the context otherwise requires—"the principal Act" means the Family Allowances Act (Northern Ireland), 1945;
  - "the Act of 1952" means the Family Allowances and National Insurance Act (Northern Ireland), 1952;

- "allowance" means an allowance under the principal Act;
- "the appointed day" means the 2nd September, 1952;
- "the Qualifications Regulations" means the Family Allowances (Qualifications) Regulations (Northern Ireland), 1946 (a); and other expressions have the same meanings as in the principal Act.
- (3) References in these regulations to any enactment or regulations shall include references to such enactment or regulations as amended by any subsequent enactment, order or regulations.
- (4) The Interpretation Act, 1889 (b), applies for the purpose of the interpretation of these regulations in like manner as it applies for the purpose of the interpretation of an Act of the Parliament of Northern Ireland.

# Condition attaching to payment of increase of allowances payable under existing awards

- 2.—(1) Sub-section (1) of section 9 of the Act of 1952 (which subsection relates to the effect of existing awards) shall in its application to an award of an allowance have effect subject to the condition contained in the following paragraph of this regulation.
- (2) Without prejudice to the application of sub-section (2) of section 7 of the principal Act (which sub-section relates to the extinguishment of the right to an allowance) to so much of an allowance as is payable by a sum on account thereof made receivable under that section, the right to any additional allowance to which the said subsection (1) of section 9 of the Act of 1952 relates shall—
  - (a) as respects the period beginning with the appointed day and ending with the expiration of the order book of the person by whom sums on account of the allowance are receivable being an order book which is current on the appointed day, or, if there is no such order book, the expiration of the period of twelve months from the appointed day; and
  - (b) so far as sums on account of such additional allowance have not become receivable under the said section 7 of the principal Act;

be extinguished at the expiration of eighteen months from the appointed day.

# Amendment of Regulation 13 of the Qualifications Regulations

3. Paragraph (2) of regulation 13 of the Qualifications Regulations (which paragraph prescribes the circumstances in which an absence of a child from a parent or an interruption or reduction of a parent's contribution shall cease to be treated as temporary at the end of four

weeks) shall be amended by substituting for the words "five shillings" the words "eight shillings", and shall accordingly have effect as set out in the Schedule to these regulations.

#### SCHEDULE

PARAGRAPH (2) OF REGULATION 13 OF THE QUALIFICATIONS REGULATIONS AS AMENDED.\*

(2) Notwithstanding the provisions of sub-paragraph (c) of paragraph (1) of this regulation, any absence from a parent and any interruption or reduction of a parent's contribution falling within that sub-paragraph shall cease to be treated as temporary if provision has been made for the child, other than by a person within the meaning of paragraph (2) of regulation 12, for a period of four weeks during which no such person other than that parent has been providing in his own home for the child or contributing at the rate of eight shillings a week or more to the cost of providing for the child elsewhere.
