

## SCHEME FOR THE ISSUE OF LOANS

*Part 1.—Loans to Proprietors of Existing Establishments.*

An application for a loan for the purpose of furnishing, equipping, improving, altering, enlarging or structurally modifying any Registered Catering Establishment shall be made by the proprietor of such establishment and shall be in writing.

An application shall be accompanied by the recommendation of the Northern Ireland Tourist Board and shall state for which of the various purposes in said section mentioned the loan is required.

No loan shall be granted of less amount than £250.

*Part 2.—Loans for the provision of Additional Establishments.*

Where the Northern Ireland Tourist Board has certified that additional catering establishments are desirable in any district, an applicant for a loan for the provision of such establishment as aforesaid, shall make application in writing to the Ministry, furnishing such particulars and information as may be required by the Ministry.

No loan shall exceed 50 per cent. of the value of the lands and buildings in respect of which the loan is issued.

*Part 3.—General.*

A loan, if made, shall bear interest at the current rate for Tourist Development Loans as fixed by the Ministry of Finance, and shall be secured in such manner as the Ministry, with the approval of the Ministry of Finance, shall direct and shall be repayable with interest at the times and in such manner as shall be agreed between the Ministry and the Borrower.

All legal costs, including stamp duty and registration fees, shall be paid by the borrower.

The Ministry shall be at liberty to require proof that the whole of the loan has been expended for the purpose for which it was made, and may require expenditure to be vouched.

## Notices to Cleanse Watercourses

REGULATIONS, DATED 26TH SEPTEMBER, 1952, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 19 OF THE DRAINAGE ACT (NORTHERN IRELAND), 1947 (REPRINT TO 1952).

1952. No. 194

The Ministry of Agriculture, in exercise of the powers conferred on it by sub-section (8) of section nineteen of the Drainage Act (Northern Ireland), 1947 (Reprint to 1952) and of all other powers enabling it in that behalf, hereby makes the following regulations :

1. Every notice served by a county council under paragraph (b) of sub-section (2B) of section nineteen of the Drainage Act (Northern Ireland), 1947 (Reprint to 1952) shall be in Form No. 1 set out in the Schedule hereto, or as near thereto as practicable.

2. Every notice served by a county council under sub-section (3) of the said section shall be in Form No. 2 set out in the Schedule hereto, or as near thereto as practicable.

3. Every notice served by a county council under sub-section (5) of the said section shall be in Form No. 3 set out in the Schedule hereto, or as near thereto as practicable.

4.—(1) These Regulations may be cited as the Drainage (Notices to Cleanse Watercourses) Regulations (Northern Ireland) 1952, and shall come into operation on the date hereof.

(2) The Interpretation Act, 1889, as applied to Northern Ireland by the Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(3) The forms of notice prescribed by these Regulations shall be in substitution for the forms previously prescribed by the Ministry of Agriculture under the provisions of section nineteen of the Drainage Act (Northern Ireland), 1947.

IF YOU OBJECT to the requirements of this Notice you may under the provisions of sub-section (5) of the said section nineteen lodge with the County Council, within fourteen days after the service of this Notice on you, a statement setting out the grounds of your objections.

IF YOU OBJECT to comply with the requirements of this Notice, you may, under the provisions of sub-section (6) of the said section nineteen of the Drainage Act (Northern Ireland), 1947 (Reprint to 1952), appeal to the County Court on any ground specified in your said statement of objections provided that within fourteen days after the service of this Notice you give to the County Council a notice of your intention so to appeal setting forth the ground or grounds on which your appeal is brought.\*

REGULATIONS, DATED 1ST JULY, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1951, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Institutions of Further Education (Salaries and Allowances of Teachers) Amending Regulations, 1952.
