THE BAKING WAGES COUNCIL (NORTHERN IRELAND) WAGES REGULATION (AMENDMENT) (No. 4) ORDER, 1952, DATED 18TH SEPTEMBER, 1952, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 10 OF THE WAGES COUNCILS ACT (NORTHERN IRELAND), 1945 (9 & 10 GEO. 6, CH. 21).

Whereas the Ministry of Labour and National Insurance (hereinafter referred to as "the Ministry") has received from the Baking Wages Council (Northern Ireland) wages regulation proposals for the further amendment of the Baking Wages Council (Northern Ireland) Wages Regulation (No. 5) Order, 1951 (a) (hereinafter in this Order referred to as "Order N.I.Bk. (149)") dated the 21st day of December, 1951, as amended by the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 2) Order, 1952 (b) dated the 16th day of June, 1952, which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates;

Now, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order:—

- 1. As from the specified date Order N.I.Bk. (149) as amended shall Statutory have effect subject to the further amendments set out in the Schedule minimum reto this Order.
- 2. In this Order the expression "the specified date" means the 29th Commenceday of September, 1952. Provided that where, as respects any worker ment who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.
- 3.—(1) This Order may be cited as the Baking Wages Council Short title (Northern Ireland) Wages Regulation (Amendment) (No. 4) Order, and interpretation. 1952.
- (2) The Interpretation Act, 1889, applies to the interpretation 52 & 53 of this Order as it applies to the interpretation of an Act of the Parliament Vict. Ch. 63 of Northern Ireland.
