MILK FUND

Act (Northern Ireland), 1926, with the approval of the Ministry of Finance, hereby makes the following Regulations :---

1. The contributions payable by the council of a county or county borough under the said sub-section in respect of a youthful offender in the School referred to in that sub-section during any period or periods occurring after the thirty-first day of March, nineteen hundred and fifty-two, and before the first day of April, nineteen hundred and fiftythree, shall be at the rate of fifty-nine shillings and two pence (59/2d.)for each week during which he is so detained.

2. Payment of the contribution as aforesaid shall be in arrear, and shall be made half-yearly by the council of the county or county borough in respect of the half-years ending 30th September and 31st March, respectively, and shall be made not later than two months from the date of the claim for payment.

3. These Regulations may be cited as the Malone Training School (Contributions) Regulations, 1952.

MILK FUND (WINDING UP)

Order, dated 10th March, 1952, made by the Ministry of Agriculture under section six of the Milk Act (Northern Ireland), 1950 with the approval of the Ministry of Finance.

1952. No. 30

WHEREAS by section six of the Milk Act (Northern Ireland), 1950 (in this Order referred to as "the Act") it is provided that as from the coming into operation of that section the Milk Fund therein referred to shall by virtue thereof be wound up and thereupon there shall be made such payments as the Ministry of Agriculture (hereinafter referred to as "the Ministry") may, by Order made with the approval

of the Ministry of Finance and after consultation with the Ministry of Food, specify in that behalf.

AND WHEREAS by section fifteen of the Act it is provided that the said section six shall come into operation on the day on which Part III of the Defence (Agriculture and Fisheries) (Northern Ireland) Regulations, 1940, shall cease to have effect.

AND WHEREAS by the Defence Regulations (No. 2) Order, 1951, made the fifteenth day of March, 1951, the said Part III was revoked as from the first day of April, 1951.

AND WHEREAS the Ministry of Finance has approved and the Ministry of Food has been consulted with respect to the payments hereinafter referred to.

Now THEREFORE the Ministry makes the following Order :---

1. The Ministry specifies that on the winding up of the abovementioned Milk Fund there shall be made, out of the balance remaining therein, the following payments, that is to say :---

to the Ministry of Food, the sum of £31,825 6s. 0d.; and

to the Exchequer of Northern Ireland, the sum of $f_{.15,074}$ 9s. 11d.

2. This Order may be cited as the Milk Fund (Winding up) Order (Northern Ireland), 1952.
