# Foyle Area (Returns by Licence Holders) Regulations, 1952

REGULATIONS DATED 9TH APRIL, 1952, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE OF THE REPUBLIC OF IRELAND AND THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT, 1952, AND SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND), 1952.

# 1952. No. 54

The Foyle Fisheries Commission hereinafter referred to as "the Commission" in exercise of its powers under Section 13 of the Foyle Fisheries Act, 1952 and Section 13 of the Foyle Fisheries Act (Northern Ireland), 1952 hereby makes the following regulations:—

- 1. These regulations may be cited as the Foyle Area (Returns by Licence Holders) Regulations, 1952.
- 2.—(1) In this article the expression "scheduled licence" means any of the kinds of licence specified in the First Schedule hereto and

issued by the Commission in pursuance of the Foyle Area (Licensing of Fishing Engines) Regulations, 1952.

- (2) Every holder of a scheduled licence for any year shall, not later than three days after the expiration of every week which or part of which is in the fishing season of such year, make to the Commission a return of the catch taken during such week by the net or other engine of the kind specified in such licence.
- (3) Where a person is the holder of more than one scheduled licence he shall make separate returns under these regulations in respect of each such licence.
- (4) Every return under this article shall be in the form set out in the Second Schedule hereto and shall contain the particulars, relevant to the week to which such return relates, indicated in such form.
- 3.—(1) Every holder of a salmon rod licence for any year shall, not later than the 31st October in such year make to the Commission a return of the catch taken by him in the Foyle Area during the open season for angling in such year.
- (2) Every return under this article shall be in the form set out in the Third Schedule.
