

2. The existing Regulations hereby amended are the Institutions of Further Education (Salaries and Allowances of Teachers) Regulations, 1951 (a).

3. The rates of salary prescribed in Regulations 5, 7, 8 and 12 of the existing Regulations shall be increased by £40 per annum in the case of men and by £32 per annum in the case of women in respect of service given on and after 1st July, 1952.

Grammar Schools (Admissions, Scholarships and Special Allowances) (Amendment) (No. 2) Regulations (Northern Ireland), 1952.

REGULATIONS DATED 9TH JUNE, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1951.

1952. No. 93

The Ministry of Education in pursuance of the powers vested in it by Section 76 of the Education Act (Northern Ireland), 1947, as amended by the Education (Extension of Benefits) Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

- 1.—(a) These Regulations may be cited as the Grammar Schools (Admissions, Scholarships and Special Allowances) (Amendment) (No. 2) Regulations (Northern Ireland), 1952.
- (b) These Regulations shall be construed as one with the Grammar Schools (Admissions, Scholarships and Special Allowances) Regulations (Northern Ireland), 1950 (hereinafter referred to as “the Principal Regulations”) as amended by the Grammar Schools (Admissions, Scholarships and Special Allowances) (Amendment) Regulations (Northern Ireland), 1951.
- (c) The Principal Regulations, the Grammar Schools (Admissions, Scholarships and Special Allowances) (Amendment) Regulations (Northern Ireland), 1951, and these Regulations may be cited together as the Grammar Schools (Admissions, Scholarships and Special Allowances) Regulations (Northern Ireland), 1950 to 1952.

(d) These Regulations shall come into operation on 1st August, 1952.

2. The Principal Regulations shall have effect as if for Regulation 8 thereof there were substituted the following Regulation :—

“ 8.—(1) An award shall consist of—

(a) a scholarship of a value equal to—

(i) in the case of a pupil who is in attendance at a Group A voluntary school or county school, the approved tuition fee of the school ; or

(ii) in the case of a pupil who is in attendance at a Group B voluntary school, an amount determined by the Ministry :

together with the amount, as certified by or on behalf of the school authorities and approved by the local education authority, of examination fees ;

(b) such allowance in respect of books, stationery and other school requisites as may be granted in accordance with the provisions of paragraph (2) of this Regulation ; and

(c) such special allowances as may be granted in accordance with the provisions of paragraphs (3) and (4) of this Regulation.

(2) An allowance in respect of books, stationery and other school requisites shall be such amount as may be determined by the local education authority and approved by the Ministry and may be paid either to the School Authorities, the parent or otherwise for the benefit of the pupil as the local education authority may decide.

(3) Where, upon application made by the parent of a pupil to whom an award of a scholarship is made under the last preceding Regulation, it appears to the local education authority that it is necessary, for the purpose of the avoidance or alleviation of hardship to the pupil or his parents, that an allowance should be granted in respect of incidental expenses arising out of his attendance at the school, the local education authority may grant in respect of such pupil a special allowance (in these Regulations referred to as an incidentals allowance) calculated in accordance with and not exceeding the amount set forth in the Schedule to these Regulations.

(4) If in respect of any qualified pupil the local education authority are satisfied—

(a) that, whereby reason of the distance between his home and the nearest suitable school, or other sufficient cause, it would be unreasonable that he should attend a school as a day pupil ; and

(b) that it is necessary that, for the purpose of the avoidance or alleviation of hardship to that pupil or his parents, a special allowance should be granted so as to enable him to attend a suitable school as a boarder ;

the local education authority may in their discretion grant in respect of that pupil a special allowance (in these Regulations referred to as a boarding allowance) of such value as the authority may with the approval of the Ministry determine."

Grammar School (Grant Conditions) Amending Regulations, 1952

REGULATIONS DATED 1ST JULY, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1951, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations.

1. These Regulations may be cited as the Grammar School (Grant Conditions) Amending Regulations, 1952.

2. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations, 1948 (a), as amended by the Grammar School (Grant Conditions) Amending Regulations, 1949 (b), 1950 (c) and 1951 (d).

3. Paragraph 2 of the Third Schedule to the existing Regulations which, as amended by the Grammar School (Grant Conditions) Amending Regulations No. 2, 1951, provides for the payment of salary grant, shall have effect as if for the figure "£300" in the aforesaid paragraph there were substituted "£340 in the case of a man and £332 in the case of a woman".

This Regulation shall come into operation on the first day of July, 1952, and shall not apply to the salary payable in respect of service rendered by any teacher before that date.
