(45)") dated the 16th day of September, 1952, which fixes the minimum remuneration to be paid to the workers in relation to whom the General Waste Materials Reclamation Wages Council (Northern Ireland) operates;

Now, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order:—

- 1. As from the specified date Order N.I.W.R. (45) shall have effect subject to the amendments set out in the Schedule to this Order.
- In this Order the expression "the specified date" means the 27th day of July, 1953. Provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

SCHEDULE

STATUTORY MINIMUM REMUNERATION

Order N.I.W.R. (45) shall have effect as if, in the Schedule thereto, the following new paragraph were inserted immediately following paragraph 4 thereof -

"SHIFT WORKERS

Paragraph 4a.

Notwithstanding the provisions of paragraphs 1 and 3 of this Schedule male workers employed on a shift system shall be entitled -

(a) in the case of workers employed on a shift which commences not earlier than 6 a.m. and finishes not later than 10 p.m. on any day, to an amount of 3d. per hour for all time so worked in addition to the statutory minimum. otherwise payable,

(b) in the case of workers employed on a shift which commences not earlier than 10 p.m. on one day and finishes not later than 6 a.m. on the next following day, to the appropriate minimum rate set out in paragraph 1 or 3 of this Schedule increased by twenty per cent.

"Shift system" means a system of working which involves successive turns of duty for different groups of workers in the establishment in which they are employed."
