THE IMPORTATION OF LETTUCE FROM SOUTHERN FRANCE (REVOCATION OF EXEMPTION) (NORTHERN IRELAND) ORDER, 1953.

1953. No. 40

This Order revoked from the 16th March, 1953, the Importation of Lettuce from Southern France (Exemption) (Northern Ireland) Order, 1953, which relaxed for the month of March, 1953, the requirements of the Importation of Plants (Amendment) (Northern Ireland) Order, 1953, relating to the importation of lettuce from France south of latitude 46° N. by permitting a Certificate of Origin to be given instead of the Form A specified in the Importation of Plants (Northern Ireland) Order of 1947.

ORDER DATED THE 16TH DAY OF FEBRUARY, 1953, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DESTRUCTIVE INSECTS AND PESTS ACTS (NORTHERN IRELAND), 1877 TO 1934.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Destructive Insects and

Pests Acts (Northern Ireland), 1877 to 1934, and of every other power enabling it in that behalf, orders, and it is hereby ordered, as follows :—

Citation, Commencement and Construction

1.—(1) This Order may be cited as the Importation of Plants (Amendment) (Northern Ireland) Order, 1953, and shall come into operation on the first day of March, nineteen hundred and fifty three, and shall be construed as one with the Importation of Plants (Northern Ireland) Order of 1947 (hereinafter referred to as “the principal Order”) and the Importation of Plants (Amendment) (Northern Ireland) Order, 1952, (hereinafter referred to as “the Order of 1952”). The principal Order, the Order of 1952 and this Order may be cited together as the Importation of Plants (Northern Ireland) Orders, 1947 to 1953.

(2) Forms referred to in this Order are the forms set out in the Third Schedule to the principal Order.

Amendment of Article 8 of the principal Order

2. In Article 8 of the principal Order after paragraph (2) there shall be inserted the following paragraph :—

“(2a) The foregoing paragraphs of this Article shall not apply to lettuce.”

Restriction on landing of lettuce in Northern Ireland

3.—(1) The landing in Northern Ireland between the first day of March and the fifteenth day of October in any year of any lettuce grown in Europe south of latitude forty-six degrees North is hereby prohibited unless each consignment is accompanied by a certificate of a duly authorised Official of the Phytopathological Service of the country in which the lettuce were grown, in Form A.

(2) The landing in Northern Ireland of any lettuce grown in Europe at or north of latitude forty-six degrees North is hereby prohibited :—

(a) during the month of March in any year unless each consignment is accompanied by a certificate of origin visé by a competent authority in the country of origin stating the country and place where the lettuce were grown, and declaring that the lettuce were grown at or north of latitude forty-six degrees North ;

(b) between the first day of April and the fifteenth day of October in any year unless each consignment is accompanied by a certificate of a duly authorised Official of the Phytopathological Service of the country in which the lettuce were grown, in Form A.

(3) The landing in Northern Ireland between the first day of April and the fifteenth day of October in any year of any lettuce grown

in the United States of America or Canada is hereby prohibited unless each consignment is accompanied by a certificate of a duly authorised Official of the Phytopathological Service of the country in which the lettuce were grown, in Form A or Form B.

(4) The landing in Northern Ireland between the first day of April and the fifteenth day of October in any year of any lettuce grown elsewhere than in any European country, the United States of America or Canada is hereby prohibited unless each consignment is accompanied by a certificate of origin visé by a competent authority in the country of origin stating the country and place where the lettuce were grown.

(5) The certificates prescribed in this Article shall be delivered to the proper Officer of Customs and Excise at the same time as and together with the entry relating to the consignment.

THE IMPORTATION OF PLANTS FROM BELGIUM, FRANCE AND THE NETHERLANDS (EXEMPTION) (NORTHERN IRELAND) ORDER, 1953.
