

THE CATERING ESTABLISHMENTS (REGISTRATION CERTIFICATES) REGULATIONS 1953, DATED 20TH FEBRUARY, 1953, MADE BY THE MINISTRY OF COMMERCE UNDER SECTION 13 OF THE DEVELOPMENT OF TOURIST TRAFFIC ACT (NORTHERN IRELAND) 1948.

1. The Ministry of Commerce in pursuance of the powers conferred on it by Section 13 of the Development of Tourist Traffic Act (Northern Ireland) 1948 as amended by the Development of Tourist Traffic (Amendment) Act 1952, and of every other power in that behalf it thereunto enabling hereby revokes the Catering Establishment (Registration Certificates) Regulations (Northern Ireland) 1948 No. 165 and in lieu thereof prescribes that a Certificate of Registration issued by the Northern Ireland Tourist Board shall be in such one of the forms set out in the Schedule hereto as shall be appropriate to the Catering Establishment therein mentioned.

- 2.—(a) These regulations may be cited as the Catering Establishments (Registration Certificates) Regulations (Northern Ireland), 1953.
- (b) The Interpretation Act 1889 as in force in Northern Ireland shall apply to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

1. The Ministry of Commerce in pursuance of the powers conferred on it by Section 22A of the Development of Tourist Traffic Act (Northern Ireland), 1948, as amended by Section 5 of the Development of Tourist Traffic (Amendment) Act (Northern Ireland), 1952 and of every other power enabling it in that behalf and after consultation with the Northern Ireland Tourist Board, hereby prescribes that the Visitors Register required to be kept by the registered proprietor of any registered Catering Establishment (other than a restaurant) shall contain the full name, the permanent address, the nationality, the date of arrival and the date of departure of each visitor.

2.—(a) These Regulations may be cited as the Catering Establishments (Visitors Register) Regulations (Northern Ireland), 1953.

(b) The Interpretation Acts 1889 and 1921 shall apply for the purpose of the interpretation of these Regulations as they apply to the interpretation of an Act of Parliament of Northern Ireland.
