THE BRUSH AND BROOM WAGES COUNCIL (NORTHERN IRELAND) WAGES REGULATION (AMENDMENT) ORDER, 1953, DATED 5TH FEBRUARY, 1953, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 10 OF THE WAGES COUNCILS ACT (NORTHERN IRE-LAND), 1945 (9 & 10 GEO. 6, CH. 21).

#### 1953. No. 45

WHEREAS the Ministry of Labour and National Insurance (hereinafter referred to as "the Ministry") has received from the Brush and Broom Wages Council (Northern Ireland) wages regulation proposals for the amendment of the Brush and Broom Wages Council (Northern Ireland) Wages Regulation Order, 1948 (a) (hereinafter in this Order referred to as "Order N.I.B.B. (56)") dated the 14th day of January, 1948, as amended by the Brush and Broom Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1952 (b) (hereinafter in this Order referred to as "Order N.I.B.B. (65) ") dated 14th August, 1952, which specifies the minimum remuneration to be paid to the workers in relation to whom the Brush and Broom Wages Council (Northern Ireland) operates;

Now, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order :--

(2) The operations or branches of work referred to in sub-paragraph (1) of this paragraph are as follows :---
