

1.—(1) These Regulations may be cited as the Nursery Schools (Amendment) Regulations (Northern Ireland), 1953.

(2) These Regulations shall come into operation on the 1st day of August, 1953.

2. The existing Regulations hereby amended are the Nursery Schools Regulations (Northern Ireland), 1948.

3. For Regulation 11 (1) of the existing Regulations there shall be substituted the following Regulation :—

“ 11.—(1) A nursery school shall be open for not less than 200 school days in each school year : provided that in exceptional circumstances the Ministry may approve a lesser number of days of opening.”

REGULATIONS, DATED 10TH JUNE, 1953, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1953, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as “ the Ministry ”) in pursuance of the powers vested in it by Sections 83, 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations :

1.—(1) These Regulations may be cited as the Nursery Schools (Amendment) Regulations (Northern Ireland), No. 2, 1953.

(2) These Regulations shall come into operation on the date hereof.

2. The existing Regulations hereby amended are the Nursery Schools Regulations (Northern Ireland) 1948.

3. Regulation 13 of the existing Regulations is hereby revoked.

4. For Regulation 14 of the existing Regulations there shall be substituted the following Regulation :—

14. The teaching and nursery assistant staff of a nursery school shall be such as the Ministry may from time to time approve, having regard to the actual, or prospective, enrolment.

### **Primary Schools (General) Amending Regulations, 1953**

REGULATIONS, DATED 13TH JANUARY, 1953, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1952.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Section 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1. These Regulations may be cited as the Primary Schools (General) Amending Regulations (Northern Ireland), 1953.

2. These Regulations shall come into operation on the first day of August, 1953.

3. The existing Regulations hereby amended are the Primary Schools (General) Regulations (Northern Ireland), 1949 (a), as amended by the Primary Schools (General) Amending Regulations (Northern Ireland), 1950 (b) and 1952 (c).
