

Whereas by sub-section (2) of Section Thirteen of the Slaughterhouses Act (Northern Ireland), 1953 (hereinafter referred to as "the Act") it is provided that the Act shall come into operation on such day as the Ministry shall by Order appoint, and different days may be so appointed for different provisions of the Act, the Ministry of Agriculture for Northern Ireland hereby makes the following Order:

- (1) The appointed day for all the purposes of the said Act shall be the second day of July, 1954.
- (2) This Order may be cited as the Slaughterhouses (Appointed Day) Order (Northern Ireland), 1954.

Exemption Order

ORDED, DATED 28TH JUNE, 1954, MADE BY THE MINISTRY OF AGRICULTURE UNDER SUB-SECTION (8) OF SECTION ONE OF THE SLAUGHTERHOUSES ACT (NORTHERN IRELAND), 1953.

Whereas by sub-section (8) of Section One of the Slaughterhouses Act (Northern Ireland), 1953 (hereinafter referred to as "the Act") it is provided that the Ministry may by Order exempt certain classes of slaughter from the provisions of sub-section (7) of Section One of the Act the Ministry of Agriculture for Northern Ireland hereby makes the following Order:

1. This Order may be cited as the Slaughterhouses (Exemption) (Northern Ireland) Order, 1954.

2. A person slaughtering any animal for human consumption shall be exempt from the provisions of sub-section (7) of Section One of the said Act (which declares it to be unlawful for a person to slaughter or cause or permit to be slaughtered for human consumption an animal of any kind except at a Slaughterhouse duly licensed under the Act or operated by the Ministry) if the circumstances of the slaughter are within any of the provisions hereinafter mentioned that is to say where

- (a) the slaughter in any part of Northern Ireland is of pigs for sale to a person who is a licensed bacon curer within the meaning of the Agricultural Produce (Meat Regulation) Act (Northern Ireland), 1930. This exemption shall not apply when the animal is slaughtered at the premises of a person who carries on the business of slaughtering pigs for fee or reward.
- (b) the slaughter is on a farm in Northern Ireland of an animal the property of the owner or occupier of the farm on which the animal is slaughtered for the purpose of its being consumed in the household of such owner or occupier;

- (c) the slaughter is of any animal under or by virtue of the Diseases of Animals Acts (Northern Ireland), 1894 to 1948;

Provided that the above mentioned exemptions shall not apply unless in each case the animal is instantaneously slaughtered or by stunning instantaneously rendered insensible to pain until death supervenes, and such slaughtering or stunning shall be effected by a person who is at the time the holder of a licence issued by the local authority and shall be so effected by means of a mechanically operated instrument in proper repair and of a type approved by the local authority;

- (d) the slaughter is of animals whose immediate slaughter becomes necessary or expedient by reason of injury or by reason of infirmity other than disease within the meaning of the Diseases of Animals Acts (Northern Ireland), 1894 to 1948.

RULES MADE BY THE SUMMARY JURISDICTION RULES COMMITTEE UNDER SECTION 2 OF THE SUMMARY JURISDICTION ACT (NORTHERN IRELAND), 1953, WITH THE APPROVAL OF THE LORD CHIEF JUSTICE.

We, the undersigned members of the Summary Jurisdiction Rules Committee appointed by the Minister of Home Affairs under sub-section (2) of section 1 of the Summary Jurisdiction Act (Northern Ireland), 1953, by virtue of the powers vested in us by section 2 of the said Act, do hereby make the Rules hereinafter set forth as summary jurisdiction rules in regard to ejectment proceedings to be in force in the courts of summary jurisdiction in Northern Ireland, and, in pursuance of the provisions of sub-section (1) of section 3 of the said Summary Jurisdiction Act (Northern Ireland), 1953, do hereby certify the same under our hands and do submit them to the Lord Chief Justice of Northern Ireland.
