

INTOXICATING LIQUOR**Compensation: Charges in respect of Licences**

ORDER, DATED 4TH JUNE, 1954, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE INTOXICATING LIQUOR ACT (NORTHERN IRELAND), 1923, AS AMENDED BY THE INTOXICATING LIQUOR (FINANCE) ACT (NORTHERN IRELAND), 1925.

1. In pursuance of sub-sections (3)(b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th day of September, 1955, shall be fourteen shillings and tenpence for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

2. This Order may be cited as the Intoxicating Liquor (Compensation Charges) Order (Northern Ireland), 1954.

ORDER, DATED 21ST MAY, 1954, MADE BY THE LORD CHIEF JUSTICE AND THE CHANCERY JUDGE UNDER SECTION NINETY-FOUR OF THE LOCAL REGISTRATION OF TITLE (IRELAND) ACT, 1891 (a), AS AMENDED BY SECTION THREE OF THE ADMINISTRATIVE AND FINANCIAL PROVISIONS ACT (NORTHERN IRELAND), 1951 (b).

We, the Lord Chief Justice and the Chancery Judge, after consultation with the President of the Incorporated Law Society of Northern Ireland, the Taxing Master of the Supreme Court of Judicature of Northern Ireland and the Registrar of Titles in Northern Ireland, and in exercise of the powers conferred upon us by section ninety-four of the Local Registration of Title (Ireland) Act, 1891, as amended by the Northern Ireland (Land Registry) (Adaptation of Enactments) Order, 1948 (c) and section three of the Administrative and Financial Provisions Act (Northern Ireland), 1951, do hereby make the following Order:—

1. The Schedule of Costs referred to in the Land Registry (Costs) Order (Northern Ireland), 1953 (d) is hereby annulled save in respect of business completed prior to the first day of July, 1954, and there shall be substituted therefor the Schedule of Costs hereto annexed, which shall apply subject to the regulations therein mentioned.

2. The Schedule of Costs hereto annexed shall apply to all business completed on or after the date on which this Order comes into force.

3. This Order, which may be cited as the Land Registry (Costs) Order (Northern Ireland), 1954, shall come into force on the first day of July, 1954.
