The Ministry of Home Affairs, in exercise of the powers vested in it by Sections Sixteen and Fifty-Four of the Elections and Franchise Act (Northern Ireland), 1946 (a), and of every other power it thereunto enabling, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Electoral (Registration) Regulations (Northern Ireland), 1954.
- (2) These Regulations shall come into force on 1st September, 1954.
- (3) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them;
 - "Act of 1946" means the Elections and Franchise Act (Northern Ireland), 1946, as amended by any subsequent enactment.
 - "Qualifying Address" in relation to a person means, according to the context, either—
 - (a) the address of the place in a Constituency at which that person was residing on the qualifying date; or
 - (b) the address of the dwelling house in a Local Government Electoral Area at which that person was residing as resident occupier or as the spouse of such occupier on the qualifying date; or
 - (c) the address of the premises in a Constituency or in a Local Government Electoral Area by virtue of the occupation of which the person has, or claims to have, a Business Premises or General Occupier's qualification as a Parliamentary or Local Government elector respectively; or
 - (d) the address given in the declaration of residence made by any person claiming to have a Service qualification.
 - "Service Voter" means a person qualified to be registered by virtue of a Service qualification under the provisions of the Act of 1946.
 - "The Ministry" means the Ministry of Home Affairs for Northern Ireland.

- (4) References in these Regulations to an election shall be construed as referring only to an election for which a Register prepared under the Act of 1946 or these regulations is in force.
- (5) The Interpretation Act, 1889, (a), shall apply to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2.—(1) Not less than 15 days before the qualifying date for any Register the Electoral Officer shall give public notice in the form set out in the Second Schedule hereto that a Register is about to be prepared.
- (2) On or before the qualifying date every Assistant Electoral Officer shall initiate such enquiries as may be necessary to enable him to furnish, within the period prescribed therefor in the First Schedule hereto
 - (a) in the case of an area situate within a Borough or Urban District to the Deputy Electoral Officer; or
- (b) in the case of an area situate in a rural district to the Electoral Officer for the County a list, in the form set out in the Second Schedule hereto, of the

names of those persons within his area who appear to be qualified to be registered as Parliamentary or Local Government Electors.

- (3) In the execution of the duties imposed on him by paragraph (2) of this Regulation an Assistant Electoral Officer may, as he deems it necessary, and subject to any special instruction given to him by the Electoral or Deputy Electoral Officer or by the Ministry conduct his enquiries by securing the due completion of the appropriate form prescribed by these Regulations, or in such other manner as seems to him adequate and appropriate, and, subject to the provisions of the Act of 1946, and of these Regulations in relation to Claims and Objections, it shall be the responsibility of the Assistant Electoral Officer to ensure that the information furnished by him under this Regulation is complete and accurate.
- (4) During the period intervening between the publication of one Register and the qualifying date for the next succeeding Register, an Assistant Electoral Officer, if required to do so by the Electoral or Deputy Electoral Officer, shall keep and maintain such records as shall facilitate the determination of the qualification of persons within his area to be entered in the Electors Lists for the next Register and the preparation of such lists as quickly as possible after the qualifying date for such Register, and the maintenance of such records shall be part of the duties of the Assistant Electoral Officer.
- (5) It shall be the duty of the Assistant Electoral Officer to indicate on the list the nature of the qualification and where the name of any person is included by reason of a qualification other than a Residence qualification or a Resident Occupier's qualification, to enter on the list, opposite the name of the person, the address, if any, in respect of which the person possesses a Residence or Resident Occupier's qualification.

- 3.—(1) On receiving the lists of persons qualified to be Electors within his District from the Assistant Electoral Officers, the Deputy Electoral Officer for a Borough or Urban District shall prepare from them a list of Electors for the Borough or Urban District in the form set out in the Second Schedule hereto, and shall transmit the said list, within the time set out in the First Schedule hereto, to the Electoral Officer for the County in which the Borough or Urban District is situate.
- (2) The list so transmitted shall show the names of all persons who appear to be qualified, by any qualification, to be Parliamentary Electors or Electors at Elections to the Borough or Urban District Council.
- 4. It shall be the duty of every Electoral Officer, Deputy Electoral Officer, and Assistant Electoral Officer, to give all possible assistance to any other Electoral Officer, Deputy Electoral Officer or Assistant Electoral Officer, and, in particular, to furnish any information properly required by him in the performance of his electoral duties.
- 5.—(1) A Company may claim to be entitled to have a person (or persons) registered as a Local Government Elector (or Electors) in respect of land or premises occupied by it by sending to the Electoral Officer within the time specified in the First Schedule hereto a claim in the form set out in the Second Schedule hereto.

The first claim made under this Regulation shall be accompanied by a Delegation of Authority to claim in the form set out in the Second Schedule hereto and duly executed in accordance with the provisions of the Act of 1946. Such authority shall be retained by the Electoral Officer and shall remain in force until the revocation of such authority under the seal of the Company is lodged with the Electoral Officer.

- (2) If a Company in a claim made under this Regulation specifies more persons than it is entitled to specify in respect of the Company qualification claimed by the Company, the Electoral Officer shall delete the names of so many persons commencing with the last name on the list as may be necessary in order that the number of names specified may be that which the Company is entitled to specify, and shall enter the names of those persons who are qualified to be Electors in the appropriate position in the Electors Lists.
- (3) If the Electoral Officer is not satisfied that a Company is entitled to specify any persons in respect of the Company qualification claimed by the Company, or if he deletes the names of any persons specified by the Company, as provided in Paragraph (2) hereof, he shall notify the Company in writing that he is omitting from the electors lists all or some, as the case may be, of the names specified by the Company, and he shall also inform the Company of its right to make a claim under Regulation 9 hereof.

- 6.—(1) Any person claiming to be entitled to be registered as a Local Government elector under sub-section (6), sub-section (8) or sub-section (9) of section two of the Act of 1946 shall make application to the Electoral Officer on or before the date specified in that behalf in the First Schedule and in the form set out in the Second Schedule hereto.
- (2) If the Electoral Officer is satisfied that the claimant possesses the requisite qualifications, he shall enter his name in the appropriate place in the electors lists.
- (3) If the Electoral Officer is not satisfied that the claimant possesses the requisite qualifications, he shall notify the claimant in writing to that effect and shall also inform him of his right to make a claim under Regulation 9 hereof.
- (4) If any person to whom this Regulation applies omits to make application in the manner and within the time prescribed in Paragraph (1) hereof, he shall not be entitled to make any claim for registration under Regulation 9 hereof.
- (5) An application under this Regulation may be made either by the claimant or by some other person on his behalf.
- 7.—(1) When the Electoral Officer receives from the Assistant and Deputy Electoral Officers the lists of persons who appear to be qualified to be registered as Electors, he shall examine the lists and, having taken account of the information thereon furnished, together, where necessary, with additional information available to, or obtained by, himself, prepare therefrom the Electors Lists for the County or County Borough, and shall publish such lists as hereinafter provided. For the purposes of this Regulation the Electoral Officer may require any person whose name is included in the lists furnished by any Assistant or Deputy Electoral Officer to furnish to him in writing, over that person's signature, such particulars as may be necessary to enable the Electoral Officer to determine whether or not the person is entitled to be registered as a Parliamentary or Local Government Elector.
- (2) The Electors Lists for each County or County Borough shall be published in the form set out in the Second Schedule hereto.
 - (3) The names in the lists need not be numbered.
- (4) The names in the lists for each polling district shall be arranged wherever possible in street order and in all other cases in alphabetical order. The address shown opposite each name shall be the correct postal address to which communications can be sent by post but the list for any polling district may, at the discretion of the electoral officer, be subdivided to show the names of the persons registered in each townland in the polling district and in such case the names shall be arranged alphabetically in each townland and the townlands in each polling district shall be arranged in alphabetical order.
- (5) Where the name of any person is included in the lists by virtue of a Business Premises qualification or a General

Occupier's qualification, the address, if any, in respect of which that person possesses a Residence qualification or a Resident Occupier's qualification shall be shown.

- (6) The names of persons qualified to be Local Government Electors as nominees of Companies possessing a Company qualification by virtue of occupation of premises situate in any polling district shall be entered at the end of the list of electors for that polling district.
- (7) The Electors Lists shall show, in the manner specified in Paragraph (5) of Regulation 15 of these Regulations, the names and qualifications of those persons who appear to be entitled to vote as Parliamentary Electors and Local Government Electors.
- 8.—(1) The Electoral Officer shall effect formal publication of the electors lists by the exhibition in his office not later than 16th November in the appropriate registration year of a copy thereof, which copy may be in manuscript, typescript, in the form of printer's proofs, or partly in one of such forms and partly in another, and after such publication no addition to, deletion from, or amendment of, the contents of the lists shall be made.
- (2) The Electoral Officer shall effect supplementary publication of the electors lists by exhibiting in his office not later than 11th December in the appropriate registration year a printed copy of the electors lists for the County or County Borough and by exhibiting within three days thereafter relevant sections of the printed lists in suitable places to which the public have access in or near each registration unit within the County or County Borough.
- (3) If any Electoral Officer, not later than fourteen days before the said 16th November or 11th December, as the case may be, reports to the Ministry that in his opinion it will not be possible to effect the formal or supplementary publication or both formal and supplementary publication of the lists or any part thereof on the dates specified in Paragraphs (1) and (2) of this Regulation, the Ministry may, if it is satisfied that adequate grounds exist and without prejudice to any question of the default of the Electoral Officer. make an Order under the provisions of section fourteen of the Act of 1946 postponing the publication thereof to a later date.
- (4) The Electoral Officer shall permit any interested person, during ordinary office hours, to examine and make copies of any entries in the lists exhibited by him in his office.
- (5) On the day on which supplementary publication of the electors lists is effected the Electoral Officer shall give public notice by advertisement in newspapers circulating in the County or County Borough, or by the exhibition of notices in Post Offices, police barracks or public places, and in such other manner as he considers necessary, of the publication of the lists.
- (6) A notice in accordance with Paragraph (5) hereof shall be in the form set out in the Second Schedule hereto and shall state the places at which the electors lists will be available for

inspection, the places at which and the period within which claims and objections in respect of the lists may be lodged, the places at which and the date on which lists of claimants will be exhibited. The notice shall also state that Revision Courts will be held throughout the County or County Borough at which any person possessing information relevant to any case will be entitled to appear and be heard and that particulars of the times and places at which the Courts will be held may be obtained by interested persons on application to the Electoral Officer.

- 9.—(1) At any time after the publication of the Electors Lists and within the time allowed by these Regulations, any person may send, in the form set out in the Second Schedule hereto, to the Electoral Officer—
 - (a) If his name is entered in the lists in an incorrect place or manner, a claim (hereinafter referred to as a "claim for correction") that he shall be correctly registered.
 - (b) If his name is not entered in the lists, a claim to be registered as a Parliamentary or Local Government Elector.
 - (c) If his name is entered in the lists, a claim on behalf of any other person to have that person registered as a Parliamentary or Local Government Elector.
 - (d) If his name is entered in the lists, a notice of objection to the registration as a Parliamentary or Local Government Elector of a person whose name is entered in the lists.
- (2) A claim for correction shall relate only to an entry in an incorrect place or manner or to incorrect particulars in the lists.
 - (3) (a) Every claim for registration as an elector or for the correction of an entry in the electors lists shall be made on a form to be supplied by the Electoral Officer, and shall furnish the information required on the form.
 - (b) Every notice of objection shall be made on a form to be supplied by the Electoral Officer, and shall state specifically the grounds for the objection and shall furnish the information required by the form in support of the objection.
 - (c) Any claim not made on the proper form and in the proper manner, and any notice of objection which is not made on the proper form and in the proper manner or which though made on the proper form and otherwise in the proper manner, is made on alternative general grounds not specifically and fully applicable to the particular case, shall be disregarded, and shall not be deemed to be a claim or objection for the purposes of these Regulations.

- (d) A separate notice of objection shall be given in respect of each entry in the list to which objection is made, and if a single notice is given in respect of objections to two or more entries, none of the objections to which a single notice purports to relate shall be deemed to have been made in the proper manner.
- (e) In a Borough or Urban District, a claim for correction, a claim to be registered, or a notice of objection may be made to the Deputy Electoral Officer and, for the purposes of these Regulations, any claim or objection so made shall be deemed to have been made to the Electoral Officer.
- 10.—(1) On receiving a claim for correction, a Deputy Electoral Officer shall make enquiry into the matter and shall transmit the claim with his report and recommendation to the Electoral Officer.
- (2) The Electoral Officer shall consider all claims for correction and if he is satisfied that the claim may be allowed he shall so notify the claimant.
- (3) If the Electoral Officer is of the opinion that the correction cannot properly be made, or that the matter is not one appropriate to a claim for correction, he shall refer the claim to the Revising Officer for determination.
- 11.—(1) On receiving a claim for registration or a notice of objection, a Deputy Electoral Officer shall forthwith transmit it to the Electoral Officer.
- (2) The Electoral Officer shall prepare a list of all claims and notices of objection in the form set out in the Second Schedule hereto and shall publish the said list by exhibiting it on the date specified in the First Schedule hereto, at a place in or outside his office at all reasonable times accessible to the public.
- (3) All claims for registration and notices of objection shall be sent by the Electoral Officer to the Revising Officer for determination.
- (4) The Electoral Officer shall also send to the Revising Officer copies of the Electors Lists, and the lists of claims and objections with the names of the persons objected to marked thereon.
- 12.—(1) The Revising Officer shall, when fixing the time and place at which he will consider any case, have regard to the convenience of the parties to the case and shall arrange his sittings for the purpose of considering cases at such sufficient number of places and at such hours as will provide full and sufficient opportunity for the appearance of the parties.
- (2) The Revising Officer shall, on receiving particulars of any claim or objection from the Electoral Officer, send a notice, in the case of a claim to the claimant or to the person making a

claim on his behalf or, if the Revising Officer considers it expedient, to both such persons, and in the case of an objection to the person objected to and to the person making the objection, stating the time and place at which he proposes to consider the case, and the notice sent to the person objected to shall indicate the grounds upon which the objection has been made. Such notice shall wherever practicable be sent not less than four days before the day fixed for the hearing, and in any event sufficiently in advance of the day of hearing to enable the person to attend the hearing or to arrange to be represented thereat.

- (3) A notice under the preceding paragraph to a claimant or to a person making a claim on behalf of another person may, if the Revising Officer thinks fit, include a requirement that the recipient shall appear at the hearing of the case for the purpose of substantiating the claim and if that person fails to appear at the hearing the Revising Officer may disallow the claim without further enquiry.
- (4) If a person who has given notice of objection to the inclusion of any name on the electors lists fails to appear at the hearing to give evidence in support of his objection, the Revising Officer may decline to take the objection into consideration.
- (5) The Revising Officer shall consider each case at the place specified in the notice and at the time appointed for the hearing or as soon thereafter as is practicable, so however that he informs the Electoral Officer of his decision in each such case within such time as will permit the due and proper publication of the Register.
- (6) Before admitting any claim the Revising Officer shall take into account all information available to or obtainable by him from any dependable source and, notwithstanding that no formal objection may have been made to the claim by any person at the hearing, the Revising Officer shall disallow the claim if he is not satisfied of the qualifications of the claimant to be registered.
- (7) On the consideration of a case any person who appears to the Revising Officer to be interested shall be entitled to appear and be heard either in person or by any other person, other than Counsel, on his behalf, and in particular and without prejudice to the generality of the foregoing the Electoral Officer, or the Deputy or Assistant Electoral Officer for the area to which any claim or objection relates, may, and if required by the Revising Officer shall, appear at the hearing of the claim or objection and shall be entitled to be heard as an interested party.
- (8) If any person registered as an elector within the County objects to the registration of any person by, or on whose behalf, a claim for registration has been made, the objector shall be entitled, without prior notice, to appear and be heard in opposition to the claim at the hearing of the case by the Revising Officer, and any such objector shall be deemed to be an objector for the purposes of sub-section (1) of section thirty-two of the Act of 1946.

- If, pursuant to the provisions of Section thirty-two of the Act of 1946, an appeal is lodged by any person dissatisfied with the determination by the Revising Officer of a claim or objection and such appeal is determined before the date of publication of the Register to which it relates, the Electoral Officer shall give effect in the Register to such determination in like manner as he would the determination of a claim or objection determined as provided in Regulation 12 hereof; and if any such appeal is not determined until after the date of the publication of the Register the Electoral Officer shall note the effect of such determination in a list of determined appeals and shall attach a copy of such list to each copy of the Register issued or used by him for the purposes of any Parliamentary or Local Government election for which the Register may be in force and such list shall be deemed to be part of the Register for the purposes of such election.
- 14. The Electoral Officer shall prepare the Electors Lists for publication as the Register for the County or County Borough in the following manner:—
 - (a) He shall make such additions to and corrections of the electors lists as are required in order to give effect to the determination of claims or objections.
 - (b) He shall also make any such corrections in the lists, whether by way of the removal of duplicate entries or otherwise, and such additions thereto as he thinks necessary in order to ensure that no person is registered by virtue of any qualification as qualified to vote at any election at which he is precluded by the provisions of the Act of 1946 from voting, and that the lists will be complete and accurate as the Register of Electors for the County or County Borough.
 - (c) Where the Electoral Officer makes any correction in the lists otherwise than in pursuance of a claim or objection or for the purpose of correcting a clerical error, he shall give notice to the person affected by the correction and give that person an opportunity of objecting to the correction, and if necessary of being heard with respect thereto.
- 15.—(1) The Register shall be prepared in the form set out in the Second Schedule hereto.
- (2) The names in the Register shall be numbered consecutively with a separate series of numbers (beginning with the number "1") for each polling district.
- (3) For the purpose of distinguishing one series from another there shall be assigned to each polling district a separate number and the number indicating the polling district shall (without being repeated in the register against every number) be treated as incorporated with the series relating to that polling district in the Register and as forming part of each number of the series.

- (4) If an Order is made under the Local Government Acts (Northern Ireland), 1898 to 1948, to the effect that on a specified date, being a date not earlier than the commencement of the qualifying period for any Register, and not later than the date of publication of that Register, the boundary and area of any Borough or Urban District situated in any County or of any Electoral Division or Ward situated in any County, County Borough, Borough, Urban District or Rural District, shall be altered, the Electoral Officer of the County or County Borough in which any area affected by the alteration is situated shall take the alteration into account and shall so compile and publish the Register as to show the Constituency, the Local Government Electoral Area and the Electoral Division or Ward in which any qualifying address is, or is to be, situated under the provisions of the Order, notwithstanding that during the period between the commencement of the qualifying period for the Register and the date specified in the Order as the date on which the alteration is to take effect, such qualifying address may be, or have been, situated in a different Constituency, Local Government Electoral Area, Electoral Division or Ward.
- (5) To indicate whether or not a person whose name appears in the register is entitled to vote as a Parliamentary elector at elections to the Parliament of Northern Ireland, and to indicate the nature of his qualifications as such an elector, and to indicate whether or not a person whose name appears on the Register is entitled to vote as a Local Government elector and, if so, to indicate the nature of his qualifications as such an elector and the nature of the Local Government election or elections at which he is thereby qualified to vote, entries in the register shall be distinguished in the following manner:—
 - (a) Parliamentary Electors.
 - (i) If a name is preceded by the letter "N" the elector is entitled to vote as a Parliamentary elector only at elections to the Parliament of Northern Ireland.
 - (ii) If a name is preceded by the letter "B" the elector is entitled to vote as a Parliamentary elector only at elections to the Parliament of Northern Ireland by virtue of having a "business premises" qualification or of being the spouse of a person having that qualification.
 - (iii) If a name is preceded by the letter "I" the elector is not entitled to vote at elections to the Parliament of Northern Ireland.
 - (iv) If a name is preceded by the letter "L" the elector has only a Local Government qualification and cannot vote at a Parliamentary election in respect of that entry.
 - (v) If a name is preceded by the letter "S" the elector has a Service qualification.
 - (vi) If none of the foregoing letters precede a name the elector is entitled to vote as a Parliamentary elector at all Parliamentary elections.

(b) Local Government Electors.

Letters shall be placed in the appropriate space or spaces provided opposite the name of a person qualified as a Local Government elector—

- (i) If he is qualified by virtue of a Resident Occupier's qualification, the letters "R.O.";
- (ii) if he is qualified as the spouse of a person qualified by virtue of a Resident Occupier's qualification, the letters "R.O.S.":
- (iii) if he is qualified by virtue of a General Occupier's qualification, the letters "G.O.":
- (iv) if he is qualified as the nominee of a company possessing a company qualification, the letters "C.N.";
- (v) if he is qualified by virtue of section 2 (6) of the Act of 1946, the letters "M.L.";
- (vi) if he is qualified by virtue of a Service qualification, the letter "S":
- (vii) if he is qualified by virtue of section 2 (8) of the Act of 1946, the letters "XS":
- (viii) if he is qualified by virtue of section 2 (9) of the Act of 1946, the letters "B.L.".
- 16.—(1) The Electoral Officer shall publish the Register on the fifteenth day of February in every publication year by making a copy thereof available for inspection by the public at or outside his office, and formal publication of the Register shall thereby be completed.
- (2) As soon as may be, and in any event not later than five days after the formal publication of the Register the Electoral Officer shall cause copies of the Register or relevant portions thereof to be available for inspection during business hours by the public in each polling district in the County or County Borough either—

(a) in the chief or other Post Offices (if the Postmaster General gives authority for the purpose); or

- (b) in some other convenient place to which the public have access; or if it is impracticable to arrange for the use of the said Post Office or Offices and no other convenient place in the polling district is available in the nearest convenient place available outside the polling district being a place to which the public have access.
- (3) It shall be within the discretion of the Electoral Officer to determine the situation and number of the places of exhibition to ensure the adequacy of the supplementary publication required by paragraph (2).
- (4) Immediately upon the formal publication of the Register the Electoral Officer shall give public notice that the Register has been published, specifying the place or places in or near each polling district at which copies of the portions of

the Register relating to that polling district are or will be available for inspection. Public notice for the purposes of this paragraph shall be given by advertisement in the form set out in the Second Schedule hereto in newspapers circulating in the County or County Borough, by the exhibition of posters or handbills at Post Offices, Police Stations, public offices or on public notice-boards, or by any other means which the Electoral Officer considers appropriate.

- 17.—(1) The Electoral Officer, on receiving, after the publication of a Register and within the period during which the Register is in force, a proxy application in the form set out in the Second Schedule hereto shall, after satisfying himself that the applicant is entitled to appoint a proxy, send to the person nominated in the application as first choice, unless he is satisfied that that person cannot lawfully be appointed, a notice intimating that it is proposed to appoint him as proxy for the voter, and that if no notice is received from him within seven days intimating that he is not willing to be appointed or cannot lawfully be appointed, his appointment will be accepted.
- (2) If at the expiration of the said seven days the said notice has not been received the Electoral Officer shall forthwith send or deliver a proxy paper in the form set out in the Second Schedule hereto to the person so nominated.
- (3) If the Electoral Officer is satisfied, or within the said seven days notice is received by the Electoral Officer informing him, that the person nominated as first choice is not willing to be appointed or cannot lawfully be appointed, the Electoral Officer shall, if another person is nominated as second choice, deal in like manner with the person so nominated.
- (4) If the person or persons nominated are unwilling to be, or cannot lawfully be appointed, the Electoral Officer shall notify the applicant to this effect and shall inform him that it is open to him to make a further nomination; and unless and until such further nomination is received by him the Electoral Officer shall take no further steps in the matter.
 - (5) (a) The appointment of a proxy for a Service voter shall remain in force so long as that voter is a Service voter or until the death of the proxy or the appointment has been cancelled.
 - (b) The appointment of proxies for other voters shall remain in force for the period specified in the application form, but in no case for longer than six months.
- 18.—(1) The Electoral Officer shall keep a record in the form set out in the Second Schedule hereto of the proxies appointed under this regulation and on receiving notification of the death of any proxy or of a person who has appointed a proxy or of the cancellation of any proxy appointment or of the appointment of a fresh proxy he shall appropriately amend the record of proxies and in like manner he shall, as necessary, delete from the record of proxies the names of proxies on the expiry of their period of appointment.

- (2) The record shall show separately the proxies appointed by Service voters, and in the case of a proxy appointment by a Service voter it shall be the duty of an Electoral Officer to delete the name of such proxy when the Service voter has been entered subsequently in the Register by virtue of a Residence qualification.
 - (3) On the initiation of a parliamentary election—
 - (a) the name of any proxy whose period of appointment expires before the date of the poll, if any, shall be deleted from the record; and
 - (b) no proxy appointment or notice of cancellation of a proxy appointment shall have effect unless respectively completed or received three clear days before the day fixed for nominations for the election.
- (4) An Electoral Officer shall on the application of any person supply to that person copies of the record of proxies at a fee of ten shillings for the first 100 names and five shillings for each further 50 names or part thereof, for the first copy and for each additional copy, one half such fee.
- 19.—(1) Subject to any modification or provision that may be made in relation to the Register for any County or County Borough by an Order of the Ministry under Section Fourteen of the Act of 1946 as provided by regulation 8 of these Regulations, the time allowed by these Regulations for any matter shall be—
 - (a) In the case of any matter mentioned in the first column of Part I of the First Schedule to these Regulations, the time mentioned in relation to that matter in the second column of that Part of that Schedule.
 - (b) In the case of any other matter the time mentioned in relation to that matter in the body of these Regulations.
- (2) Where the last day of the time allowed by these Regulations for any matter falls on a Sunday, Good Friday or a Bank Holiday, that time shall be extended until the end of the next following day which is not a Sunday, Good Friday or a Bank Holiday.
- (3) In this Regulation the expression "Bank Holiday" means a day which is a Bank Holiday under the Bank Holidays Act, 1871 (c), as amended or extended by any subsequent enactment.
- 20.—(1) For the purpose of the registration of persons qualified to be Service electors at an election to the Parliament of Northern Ireland held during the currency of the Register to be published on the 15th February in any publication year any Service declaration made to the Registration Officer for the purposes of the Representation of the People Act, 1949 (d), (hereinafter referred to as "the Act of 1949") and in force on 15th

September in the registration year for that Register, from which it would appear to the Electoral Officer that the declarant is possessed of the qualifications required under the Act of 1946, shall be deemed to be a declaration made under the Act of 1946 and any proxy appointed by any such declarant in connection with such declaration shall, unless the Electoral Officer is informed by the declarant to the contrary, be deemed to be a proxy appointed for the purposes of the Act of 1946.

- (2) Nothing in Paragraph (1) of this Regulation shall have the effect of preventing any qualified person from making a declaration in the form set out in the Second Schedule hereto for the purposes of the Act of 1946 only, whether or not such person has already made a declaration under the Act of 1949, and where a declaration has been made by a person under the Act of 1946 and also under the Act of 1949 the declaration made under the Act of 1949 may be disregarded for the purposes of the Act of 1946.
- (3) Where, in the course of the enquiries made by an Assistant Electoral Officer under Regulation 2, the name of a person is ascertained who, but for his service as a merchant seaman, would have been resident at an address within the area allotted to the Assistant Electoral Officer, a report by the Assistant Electoral Officer to that effect, in writing, shall be made, and if the Electoral Officer is satisfied from such report that the person possesses the statutory qualifications, he shall include that person's name in the electors lists as a Service voter.
- (4) Where the name of a merchant seaman is included in the electors list pursuant to the provisions of Paragraph (3) hereof, the Electoral Officer shall inform the merchant seaman of his right to appoint a proxy and shall deal with any application for the appointment of a proxy made by the merchant seaman as if it had acompanied a formal Service declaration in the prescribed form.
- 21.—(1) The forms set out in the Second Schedule to these Regulations or forms to the like effect shall be used for the purposes respectively mentioned in relation thereto in that Schedule.
- (2) The Electoral Officer shall, without fee, on the application of any person, supply him with any of the forms.
- (3) No application, claim, declaration, or notice for which a form is required by these Regulations shall be of any effect unless it gives, with reasonable clearness, the particulars and other information required by that form.
- (4) Subject to any specific provision to the contrary contained in these Regulations no such application, claim, declaration, or notice shall be invalid by reason only of the fact that it gives any such particulars or information in a manner other than that indicated by the form.

- 22.—(1) Any application to be made to the Electoral Officer under the Act of 1946 or these Regulations shall, where no form is specified, be made in writing, signed by the applicant.
- (2) Any application, claim, or notice which is required by the Act of 1946 or these Regulations to be made or sent to the Electoral Officer may be sent to him by post, addressed to him either at the address notified by him for the purpose, or at his office, unless some other method is required by these Regulations.
- (3) Any notice which is required by the Act of 1946 or these Regulations to be sent by the Electoral Officer to any person may be sent by post to the address of that person as given by him for the purpose or as appearing on the list to which the notice relates, or if there is no such address, to his last known place of abode, unless some other method is required by these Regulations.
- 23.—(1) Where the Electoral Officer is required by these Regulations to publish any document, and no specific provision is made as to the mode of publication, he shall publish the document by making copies of the document available for inspection by the public in his office.
- (2) Where the document relates to a polling district, he shall, if the circumstances appear so to require, also publish it by making copies thereof available for inspection by the public at the place or places at which the sections of the Register relating to that polling district have been or are to be made available under these Regulations.
- (3) The Electoral Officer may also, if he thinks fit, publish any document in any other manner which is in his opinion desirable for the purpose of bringing the contents of the document to the notice of the persons interested.
- (4) The documents set out in the first column of Part II of the First Schedule to these Regulations shall be kept published for the times respectively set out in the second column of that Part of that Schedule.
- (5) Any failure to publish a document in accordance with these Regulations shall not invalidate the document, but this provision shall not relieve the Electoral Officer from any penalty for such a failure.
- 24.—(1) The Electoral Officer shall, if requested by a candidate at an election, or his election agent, supply without fee for the use of the candidate in connection with the election two copies of the Register for the Constituency, Electoral Division or Ward for which he is a candidate.
- (2) On the application of any person he shall supply to the applicant copies of the Electors Lists or of the Register for the Constituency, Electoral Division or Ward, or of any part thereof, on payment of a fee of one shilling with the addition of one penny for every 100 (or part of 100) names after the first 100.

(3) When publishing the Electors Lists or Register the Electoral Officer shall cause to be printed a number of copies sufficient in his opinion to meet any applications for copies under this regulation, or other requirements.

25. The Electoral Officer—

- (a) shall allow any person to inspect and take extracts from any document required by these Regulations to be published or kept for inspection or any claim or notice of objection made under the Act of 1946;
- (b) shall within 28 days after the publication of the Register send to the Ministry one copy of the Register, together with one copy of each of the Electors Lists prepared in connection with the Register;
- (c) shall within 28 days after the publication of the Register send to the Ministry in the form set out in the Second Schedule hereto particulars of:—
 - (i) the number of Parliamentary electors registered for each Constituency;
 - (ii) the number of Local Government electors registered for each Local Government Electoral Area; and
 - (iii) the number of claims for correction, of claims for registration and of the notices of objection received, and number allowed and disallowed in each case:
- (d) shall retain until the date of publication of the next Register, all documents received or prepared in connection with claims and objections, and shall, during such period of retention, allow any authorised officer of the Ministry to inspect and take extracts from any such documents.
- 26.—(1) No misnomer or inaccurate description of any person or place on any list or on the Register or in any notice shall prejudice the operation of the Act of 1946 or these Regulations as respects that person or place provided that the person or place is so designated as to be commonly understood.
- (2) The Electoral Officer may in any case where he thinks it expedient so to do for the purpose of preventing confusion enter against the name of any person on that list or on the Register or in any notice such special designation or description as, in his opinion, appears sufficient or appropriate.
- 27. The Regulations specified in the Third Schedule hereto are hereby revoked.

- 2. Who may be appointed proxy—A person to be appointed a proxy must be duly registered as a parliamentary elector for a constituency (other than the university constituency) in Northern Ireland.

3. Powers of a Proxy—A person appointed as proxy will be able to vote on your behalf at a parliamentary election initiated during the period for which

you have appointed him.

Neither the Electoral Officer nor the election officials can be responsible for the way in which your proxy votes. It is for you to give your proxy any instructions you think necessary as to the way in which he is to vote on your behalf.

ENTERTAINMENTS DUTY

REGULATIONS, DATED 16TH SEPTEMBER, 1954, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 54(1) OF THE MISCELLANEOUS TRANSFERRED EXCISE DUTIES ACT (NORTHERN IRELAND), 1953.

1954. No. 140

The Ministry of Finance in exercise of the powers conferred on it by Subsection (1) of Section 54 of the Miscellaneous Transferred Excise Duties Act (Northern Ireland), 1953, (a) hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Entertainments Duty Regulations, 1954.
- (2) These Regulations shall come into operation on the 1st day of November, 1954.
- 2. The Entertainments Duty Regulations, 1921 (b), are hereby revoked.
- 3. In these Regulations unless the context otherwise requires—
 - "Officer" means an authorised Officer of the Ministry of Finance
 - "Entertainment" means an entertainment any payment for admission to which is subject to duty
 - "admission" means admission to an entertainment any payment for admission to which is chargeable with duty, and "admit" and "admitted" shall be construed accordingly;
 - "duty" means the entertainments duty charged by Section 44 of the Miscellaneous Transferred Excise Duties Act (Northern Ireland), 1953, as amended by any other Act or Acts
