ORDER, DATED THE 25TH DAY OF MARCH, 1954 MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DESTRUCTIVE INSECTS AND PESTS ACTS (NORTHERN IRELAND), 1877 TO 1934.

This Order permitting the importation of certain plants during the period April to October, 1954, is of temporary effect and is not printed at length in this Volume.

The Importation of Plants (Chrysanthemum Blooms)

1954. No. 24

The Ministry of Agriculture in exercise of the powers vested in it under the Destructive Insects and Pests Acts (N.I.), 1877 to 1934(a) and of every other power enabling it in that behalf orders, and it is hereby ordered as follows:—

Citation and Commencement

1. This Order may be cited as the Importation of Plants (Chrysanthemum Blooms) (Northern Ireland) Order, 1954, and shall come into operation on the 26th day of February, 1954.

Revocation of General Licence

2. The General Licence (I.P. (Northern Ireland) Gen. 3/1952) dated the 27th day of November, 1952, made by the Ministry under the Importation of Plants (Northern Ireland) Order of 1947 is hereby revoked.

Interpretation

3. In this Order the following expressions have the meanings assigned to them, that is to say:—

"Ministry" means the Ministry of Agriculture for Northern Ireland.

"Chrysanthemum blooms" means cut chrysanthemum flowers and excludes cuttings for planting, rooted cuttings and chrysanthemum plants.

4. Notwithstanding Article 6 of the Importation of Plants (Northern Ireland) Order of 1947(a), the Ministry hereby authorises the landing in Northern Ireland of chrysanthemum blooms from Great Britain, the Isle of Man or the Channel Islands subject to the following conditions:—

- (a) Each consignment shall be accompanied by a certificate issued by the appropriate Department of Agriculture to the effect that the nursery from which the cut flowers were obtained has been found during the current season to be free from Chrysanthemum Midge, and substantially free from other insect and allied pests of Chrysanthemums;
- (b) The flowers must be examined by an Authorised Officer of the appropriate Department of Agriculture within 14 days prior to shipment, and he must certify that (i) there was no evidence of Chrysanthemum Midge and (ii) the flowers were substantially free from other insect and allied pests of Chrysanthemums.
- Sealed with the Official Seal of the Ministry of Agriculture for Northern Ireland this twenty-sixth day of February, Nineteen hundred and fifty-four, in the presence of
