Brush and Broom

The Brush and Broom Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1954

1954. No. 73

Whereas the Ministry of Labour and National Insurance (hereinafter in this Order referred to as "the Ministry") has received from the Brush and Broom Wages Council (Northern Ireland) the wages regulation proposals set out in the Schedule hereto;

Now, therefore, the Ministry by virtue of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland), 1945 (a), and of all other powers enabling it in that behalf, hereby makes the following Order:—

1. The wages regulation proposals set out in the schedule hereto shall have effect as from the specified date and as from that date the Brush and Broom Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1953 (b), shall cease to have effect.

2.—(1) In this Order the expression "the specified date" means the 13th day of May, 1954, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

(2) The Interpretation Act, 1889 (c), applies to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

3. This Order may be cited as the Brush and Broom Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1954.

"Pan" (hair and bass), "Hairs," "Finishing" (that is, the work of all wood-workers employed in finishing or part-finishing brushes or brooms by hand or machine), "Boring or Drilling" (hand and machine), "Drawing," "Bone brush cutting," "Bone brush fashion-

ing," "Bone brush drilling," "Bone brush profiling," the manufacture of artists', medical, painting, whitewash, and tar brushes, and brushes not otherwise specified; and (a) the drafting, dressing (including cutting), or mixing of animal hair, bass, whisk or other fibre where the operative performs the aforesaid operations singly or in combination by hand or partly by hand and partly by machine; (b) the working of ivory or celluloid; (c) the turning of bone; where all or any of the operations specified in (a), (b), or (c) are carried on in association with or in conjunction with the manufacture of brushes (other than feather brushes) or brooms.

Whereas the Ministry of Labour and National Insurance (hereinafter in this Order referred to as "the Ministry") has received from the Dressmaking and Women's Light Clothing Wages Council (Northern Ireland) the wages regulation proposals set out in the Schedule hereto;

Now, therefore, the Ministry by virtue of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland), 1945 (a), and of all other powers enabling it in that behalf, hereby makes the following Order:—

1. The wages regulation proposals set out in the Schedule hereto shall have effect as 'from the specified date, and as from that date the Dressmaking and Women's Light Clothing Wages Council (Northern Ireland) Wages Regulation (No. 1) Order, 1953 (b), shall cease to have effect.

2.—(1) In this Order the expression "the specified date" means the 26th day of July, 1954, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

(2) The Interpretation Act, 1889 (c) applies to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

3. This Order may be cited as the Dressmaking and Women's Light Clothing Wages Council (Northern Ireland) Wages Regulation (No. 1) Order, 1954.
