

Small Dwellings Acquisition—Rate of Interest

ORDER, DATED 19TH JUNE, 1954, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION FIVE OF THE HOUSING ACT, 1921.

The Ministry of Health and Local Government for Northern Ireland, in pursuance of the powers conferred upon it by section five of the Housing Act, 1921, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby orders as follows:—

1. The rate of interest on advances to be made under section one of the Small Dwellings Acquisition Act, 1899, on or after the 21st day of June, 1954, shall be four per centum per annum:

Provided that nothing in this Order shall affect the rate of interest on any advance made or to be made or expenses incurred or to be incurred in respect of contracts entered into or applications granted under the said section prior to the 21st day of June, 1954.

2. The Rate of Interest (Housing) Order (Northern Ireland), 1953(a), made by the Ministry of Health and Local Government for Northern Ireland on the 19th day of October, 1953, is hereby revoked.

3. This Order may be cited as the Rate of Interest (Housing) Order (Northern Ireland), 1954.

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on the Ministry by section one of the Housing (No. 2) Act (Northern Ireland), 1946, and of every other power it thereunto enabling, hereby makes the following Order:—

1. In the Housing Subsidy Order (Northern Ireland), 1952 (a), as amended by the Housing Subsidy Order (Northern Ireland), 1953 (b), (which provides for the number and amount of contributions payable:—

- (a) by the Ministry to a local authority under section one of the Housing Act (Northern Ireland), 1945 (in this Order referred to as "the Act of 1945");
- (b) by a local authority to the credit of their Housing Revenue Account under section two of the Act of 1945;
- (c) by the Ministry to the Northern Ireland Housing Trust under subsections (1) and (2) of section sixteen of the Act of 1945; or
- (d) by the Ministry to a housing association under the said section one of the Act of 1945 as applied to housing associations by virtue of section twelve of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946).

for the words "thirtieth day of June, nineteen hundred and fifty-four" where they appear in the said Order there shall be substituted the words "thirty-first day of December, nineteen hundred and fifty-four".

2. The Interpretation Act, 1921, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

3. This Order may be cited as the Housing Subsidy Order (Northern Ireland), 1954.

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on the Ministry by section one of the Housing (No. 2) Act (Northern Ireland), 1946, and of every other power it thereunto enabling, hereby makes the following Order:—

1.—(1) This Order may be cited as the Housing Subsidy (No. 2) Order (Northern Ireland), 1954.

(2) The Interpretation Act, 1921, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

2.—(1) Part I of this Order shall come into effect on the first day of January, nineteen hundred and fifty-five.

(2) Part II of this Order shall come into effect on the first day of March, nineteen hundred and fifty-five.
