### Commencement Order

ORDER, DATED 12TH JANUARY, 1955, MADE BY THE MINISTER OF LABOUR AND NATIONAL INSURANCE UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1955.

Whereas it is provided by subsection (1) of section 5 of the National Insurance Act (Northern Ireland), 1955(a) (hereinafter referred to as "the Act") that "the appointed day" shall be such day as the Minister of Labour and National Insurance may by order appoint, and different days may be appointed for different purposes of the Act or for the same purpose in relation to different cases or classes of case:

Now, THEREFORE, I, THE RIGHT HONOURABLE IVAN NEILL, Minister of Labour and National Insurance for Northern Ireland, hereby make the following Order:—

- 1. The appointed day for the purposes of any subject matter specified in the second column of the schedule to this Order and contained in any provision of the Act mentioned in the first column thereof shall be the appropriate date specified in the third column of that schedule and set opposite to that subject matter.
- 2. This Order may be cited as the National Insurance and Industrial Injuries (Commencement) Order (Northern Ireland), 1955, and shall come into operation on the 13th January, 1955.
