The Minister of Agriculture by virtue and in exercise of the powers conferred upon him by sub-section (1) of Section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland), 1954, and of every other power enabling him in that behalf and with the approval of the Minister of Finance hereby makes the following Scheme:—

Definitions

- 1. In this Scheme:—
 - "Fatstock Guarantee Scheme" means the Fatstock Guarantee Scheme 1955-56 in operation in Great Britain and Northern Ireland;
 - "Pigs" means home bred clean fat pigs or the carcases of such pigs;
 - "Certification Centre" means a centre approved for certifying pigs or carcases of pigs under the Fatstock Guarantee Scheme;
 - "Certified" means certified under the Fatstock Guarantee Scheme;
 - "Score" means twenty pounds avoirdupois.
- 2. For the purpose of assisting the agricultural industry in Northern Ireland the sum specified in this Scheme shall be paid by the Ministry of Agriculture for Northern Ireland to farmers producing pigs of the description hereinafter mentioned which have, during the period set forth, been purchased by the Pigs Marketing Board (Northern Ireland) for certification under the Fatstock Guarantee Scheme at any of the Certification Centres in Great Britain and Northern Ireland. Payment shall be made to the farmer in whose name the pigs were presented for sale to the Pigs Marketing Board (Northern Ireland).
