In pursuance of the provisions of sub-section (1) of Section Ten of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, the Ministry of Home Affairs, after consultation with the County Court Judge and Resident Magistrate concerned, hereby orders and directs as follows:—

As and from the 5th day of November, 1955,

- (a) the townlands set forth in the First Schedule to this Order at present forming part of the Petty Sessions District of Claudy shall be added to and form part of the Petty Sessions District of Londonderry;
- (b) the townlands set forth in the Second Schedule to this Order at present forming part of the Petty Sessions District of Claudy shall be added to and form part of the Petty Sessions District of Dungiven;
- (c) the Petty Sessions District of Claudy shall be abolished.
