different in nature from that full-time employment" and accordingly that sub-paragraph shall have effect as set out in the schedule to these regulations.

REGULATION 6(1)(h) of the Principal Regulations AS AMENDED*

(h) (subject to the provisions of regulation 7) a day shall not be treated as a day of unemployment if on that day an insured person is following any occupation (including any occupation in an employment which, in accordance with any provision of the Act and the regulations made thereunder relating to the classification of insured persons, is to be disregarded) unless the earnings derived from that occupation, in respect of that day, do not exceed six shillings and eightpence, or where the earnings are earned in respect of a longer period than a day, the earnings do not on the daily average exceed that amount, and unless he is available on that day for full-time employment in some employed contributor's employment and the occupation which he is following is consistent with and different in nature from that full-time employment.

Increase of Benefit and Miscellaneous Provisions 449

The Ministry of Labour and National Insurance, in exercise of the powers conferred by section 32(1) of the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:—

Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Benefit) Amendment Regulations (Northern Ireland), 1955, shall be read as one with the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland), 1948(b) (hereinafter referred to as "the principal regulations") as amended(c), and shall come into operation on the 6th October, 1955.

Amendment of regulations 23 and 25 of the principal regulations

2. (1) Regulation 23 of the principal regulations, as amended (d), (which regulation relates to exceptions from disqualification for receiving benefits for periods of absence abroad) shall be further amended by the substitution of the following paragraph for paragraph (3) thereof:—

"(3) A person shall not be disqualified for receiving death benefit for any period during which he is absent from Northern Ireland."

(2) Paragraph (1) of regulation 25 of the principal regulations (which paragraph relates to suspension of payment of benefit during absence from Northern Ireland) shall cease to apply to death benefit, and accordingly for that paragraph there shall be substituted the following paragraph:—

"25. (1) The payment of injury benefit payable to any person, whether in respect of a period of absence from Northern Ireland or otherwise, shall be suspended whilst that person is absent from Northern Ireland, unless he is in the Republic of Ireland, the Isle of Man or the Channel Islands or has nominated a person in Northern Ireland (who is approved by the Ministry) to receive payment of such benefit on his behalf."
