Training Colleges

1.—(1) These Regulations may be cited as the Technical School Examinations (Amendment) (No. 5) Regulations (Northern Ireland), 1955.

(2) In these Regulations the expression "the principal Regulations" means the Technical School Examinations Regulations, 1933, as amended by subsequent Regulations other than these Regulations.

(3) These Regulations shall be construed as one with the principal Regulations.

2. The principal Regulations shall have effect as if for Regulation 15 thereof there were substituted the following Regulation:—

"15. Candidates will be notified of the result obtained by them in each subject of the examination."

3. These Regulations shall come into operation on the date hereof.

Training Colleges: Salaries and Allowances

REGULATIONS, DATED 4TH JANUARY, 1955, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1953, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations;— 1.—(1) These Regulations may be cited as the "Training College Teachers (Salaries and Allowances) Regulations, 1955."

(2) These Regulations shall have effect from 1st April, 1954.

2. For the purposes of these Regulations unless otherwise stated or unless the context otherwise requires—

- "the Ministry" means the Ministry of Education for Northern Ireland;
- "approved " means approved by the Ministry;
- "recognised" means recognised by the Ministry;
- "training colleges" means Stranmillis Training College, Belfast, St. Mary's Training College, Belfast, and the Ulster College of Physical Education, Jordanstown, County Antrim;
- "college authorities" means the committee of management or other body recognised by the Ministry as being responsible for the operation of a training college;
- "war service "means service as defined in Section 12 of the Teachers' Salaries and Superannuation (War Service) Act (Northern Ireland), 1939;
- "contributory service" has the meaning assigned to it by section 2(1)(a) of the Teachers' Superannuation Act (Northern Ireland), 1950.

3.—(1) Subject to the provisions of these Regulations the salary scales for full-time lecturers and senior lecturers employed in recognised training colleges shall be as follows:—

LECTURERS

Men: From a minimum of £665 rising by annual increments of £25 to a maximum of £940 per annum.

Women: From a minimum of £615 rising by annual increments of £25 to a maximum of £840 per annum.

SENIOR LECTURERS

Men: From a minimum of £940 rising by annual increments of £25 to a maximum of £1,140 per annum.

Women: From a minimum of £840 rising by annual increments of £25 to a maximum of £1,040 per annum.

(2) The scale salary payable to a lecturer under paragraph (1) of this Regulation shall be increased by £50 in the case of a lecturer who holds a first or second class honours degree of an approved university or a qualification which the Ministry regards as equivalent to such a degree, 4. The placing of lecturers and senior lecturers on the appropriate salary scale shall be made in accordance with the provisions of these Regulations and shall be subject to the approval of the Ministry.

5. In the case of a lecturer who was appointed before 1st April, 1954, or a senior lecturer who entered the senior lecturer grade before that date, there shall be added to the minimum of the appropriate scale in Regulation 3 of these Regulations the amount by which, immediately before these Regulations took effect, his salary on the scale then applicable to him exceeded the minimum of that scale.

6. The commencing point on the appropriate scale of a lecturer who is appointed on or after 1st April, 1954, shall be the minimum to which shall be added up to the maximum:—

 (a) in respect of previous service as a lecturer in an approved training college or university or in respect of service which the Ministry regards as equivalent thereto, increments at the rate of £25 per annum;

 (b) in respect of previous approved teaching service, not being service reckonable under (a) of this Regulation, increments in accordance with the appropriate Northern Ireland teachers' salary scale.

Incremental credit granted under (a) and (b) of this . Regulation may include credit in respect of a period of less than a year.

7.---(1) In determining the placing on the appropriate salary scale of a person appointed senior lecturer on or after 1st April, 1954, due regard shall be had to previous service of equivalent standing or to his remuneration as a teacher and the commencing salary shall not be less than the salary to which he would be entitled as a lecturer in a training college;

(2) A senior lecturer appointed on or after 1st April, 1954, shall, if immediately before that appointment he held the post of lecturer in a training college and was for a period of one year or more in receipt of salary at the maximum rate applicable to his position as a lecturer, be granted one increment on entering the senior lecturer grade.

8. The award of annual increments on the salary scale shall be subject to satisfactory service.

9. A person, who has undertaken war service, shall, if he becomes employed in contributory service before 1st April, 1960, be entitled to have that war service reckoned for increments of salary as if it had been teaching service:

Provided that war service given by a person before attaining the age of 18 years shall not be reckoned for the purpose of this Regulation.

10: In addition to the appropriate scale salary determined in accordance with the provisions of these Regulations, an allowance, at such rate as may be approved by the Ministry, may be paid to a lecturer or a senior lecturer in respect of special responsibilities.

EDUCATION

11. The scales of salary prescribed in these Regulations shall remain in force until such time as they are varied by Regulations made by the Ministry after consultation with the Ministry of Finance.

12. The salaries of the Principals of the training colleges shall be determined by the Ministry, subject to the approval of the Ministry of Finance.

13.—If any question arises as to the interpretation of these Regulations, or as to whether any of the requirements thereof are fulfilled, or as to the amount of any payment thereunder, the decision of the Ministry shall be final.

14. The Training College Teachers' (Salaries and Allowances) Regulations (Northern Ireland), 1951, as amended by the Training College Teachers' (Salaries and Allowances) Amending Regulations (Northern Ireland), 1954, are hereby revoked.
