Grants

1. The Housing on Farms Act (Northern Ireland), 1950 shall have effect as if for the words "fourth day of February, nineteen hundred and fifty-five" in sub-section (2) of sections one, four and seven, respectively, there were substituted the words "fourth day of February, nineteen hundred and fifty-six".

Citation

2. This Order may be cited as the Housing on Farms (Grants) (No. 2) Order (Northern Ireland), 1955, and shall, subject to the provisions of sub-section (4) of section twelve of the Act of 1950, have effect from the fourth day of February, nineteen hundred and fifty-five.
