REGULATIONS DATED THE 28TH DAY OF APRIL, 1955, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTIONS THIRTY AND THIRTY-TWO OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

I, THE RIGHT HONOURABLE GEORGE B. HANNA, Q.C., Minister of Home Affairs for Northern Ireland, in pursuance of sections thirty and thirty-two of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, do hereby make the following Regulations:—

1. In the First Schedule to the Principal Regulations (which specifies the poisons in respect of which special restrictions as to the persons to whom the poisons may be sold, and special requirements as to the keeping of records or rules, are imposed) after the item "Ketobemidone; its salts" there shall be inserted the item "Laudexium; its salts".

2. In each place in the Principal Regulations where the list of phosphorus compounds occurs the word "Sulphotepp" shall be inserted after the word "Schradan".

3. In the part of the Third Schedule to the Principal Regulations headed Group II (in which is specified in the second column the substances exempted, so far as the poisons specified in the first column are concerned, from the provisions of Part III of the Act, and from the provisions of the Principal Regulations), at the end of the entry in the second column opposite to the list of anti-histamine substances in the first column, there shall be added the words "and preparations containing not more than one per centum of anti-histamine substance for application in the nose or eye".

4. In these Regulations the expression "Principal Regulations" means the Poisons Regulations (Northern Ireland), 1954.

5. These Regulations may be cited as the Poisons Regulations (Northern Ireland), 1955, and shall come into operation on the 1st day of June, 1955.
