## General Dental Services

REGULATIONS, DATED 30TH APRIL, 1955, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by section eleven of the Health Services Act (Northern Ireland), 1948, and of all other powers enabling it in that behalf, and in conjunction with the Ministry of Finance for Northern Ireland, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland), 1955 and shall come into operation on the first day of May, 1955.

(2) The Health Services (General Dental Services) Regulations (Northern Ireland), 1948 to 1954 and these Regulations may be cited together as the Health Services (General Dental Services) Regulations (Northern Ireland), 1948 to 1955.

2. The Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948(a), as amended(b), shall be further amended as follows:—

For item 10 of Part I of the scale of fees set out in the Schedule there shall be substituted the following:—

(a) S.R. & O. 1948, No. 160.

(b) S.R. & O. 1949, Nos. 78 and 87; 1950, No. 65; 1951, No. 47; 1952, No. 17; 1953, No. 145; 1954, No. 138.

3. The Health Services (General Dental Services—Fees) (Amendment) Regulations, (Northern Ireland), 1950(a) are hereby revoked, without prejudice to anything duly done or suffered thereunder, as respects any payment made to a practitioner on or after the first day of May, 1955;

Provided that this revocation shall not affect any amount determined by the Board under Regulation 14 of the Health Services (General Dental Services) Regulations (Northern Ireland), 1948(b) as the amount to be paid to a practitioner by a patient and communicated to the patient before the first day of May, 1955.
