

8. In any case in which there is a change of owner or occupier before payment is made the grant shall be paid to the person who is in ownership or occupation at the time of payment.

9. The Ministry may make such inspections of the silage as it considers necessary to ensure that it is made in a proper and satisfactory manner and promoters shall afford to the Ministry, or to any of its officers, such facilities and help as may be required in carrying out such inspections.

10. Applications for assistance towards the cost of making silage will be accepted only from persons who are the owners or occupiers of the farms on which the silage has been or is to be made.

11. Forms of application for grant can be obtained from the Ministry and a promoter shall obtain such a form and make his application, in writing, thereon and he shall furnish all information therein required from him.

### **Tuberculosis (Attested Herds) (Amendment) Scheme**

SCHEME, DATED 30TH APRIL, 1955, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 10(2) OF THE AGRICULTURE ACT (NORTHERN IRELAND), 1949(a).

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers conferred on it by sub-section 2 of Section 10 of the Agriculture Act (Northern Ireland) 1949, and of every other power enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Scheme:—

#### *Citation, Commencement and Construction*

1. This Scheme, which may be cited as the Tuberculosis (Attested Herds) (Amendment) Scheme, 1955, shall come into operation on the first day of April, 1955, and shall be read as one with the Tuberculosis (Attested Herds) Scheme, 1954(b) (hereinafter referred to as "the principal Scheme").

*Amendment of the principal Scheme*

2. The principal Scheme shall be amended as follows:—

- (i) Article 3 shall be deleted.
- (ii) In Article 16 the words "Milk (Control and Maximum Prices) Order, Northern Ireland, 1951" shall be deleted and instead thereof there shall be substituted "Milk Marketing Scheme (Northern Ireland) 1955 as approved by The Milk Marketing Scheme (Northern Ireland) (Approval) Order, 1955"(a).
