REGULATIONS*, DATED 31st MAY, 1955, MADE BY THE MINISTRY OF COMMERCE UNDER SECTION 40 OF THE TRANSPORT ACT (NORTHERN IRELAND), 1948(a).

WHEREAS the Ministry of Commerce may make regulations providing for the establishment and maintenance of machinery for the following purposes:—

- (a) The settlement by negotiation of terms and conditions of employment of persons or classes of persons employed by the Ulster Transport Authority (hereinafter referred to as "the Authority") and the reference of such matters as may be agreed to arbitration in default of such settlement;
- (b) the promotion and encouragement of measures affecting the safety, health and welfare of persons or classes of persons employed by the Authority, and the discussion of other matters of common interest to the Authority and such persons:
