**Grammar School Teachers: Salaries and Allowances  
 Amending Regulations, 1956**

REGULATIONS, DATED 3RD FEBRUARY, 1956, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1953, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations shall be cited as the Grammar School (Salaries and Allowances of Teachers) Amending Regulations, 1956.

(2) The existing Regulations hereby amended are the Grammar School (Salaries and Allowances of Teachers) Regulations, 1954(a).

2. After Regulation 7 of the principal Regulations there shall be inserted the following Regulations:—

(a) Statutory Rules and Orders, 1954, No. 53

**7A.—**(1) In addition to the amount for posts of special responsibility specified in Regulation 7 of the principal Regulations there shall be available for each school an additional annual sum to provide for the payment to teachers of allowances in respect of advanced work (hereinafter referred to as "special allowances") which shall not exceed an amount calculated at the rate of £16 13s. 4d. for each pupil enrolled in the second year course and higher courses of the upper division: Provided that where the amount includes a fraction of a pound the said fraction shall be ignored if under 10s. and reckoned as £1 0s. 0d. if it is 10s. or over.

(2) In determining for the purpose of this and the next following Regulation the number of pupils enrolled in such courses that number shall be taken to be the number of such pupils on the roll of the school for the preceding school year calculated in accordance with Regulation 28 of the Grammar School (Grant Conditions) Regulations, 1948.

**7B.—**(1) The amount of the special allowance per annum together with the allowance (if any) in respect of a post of special responsibility held by an assistant teacher shall not exceed:—

- (a) £275, where the number of pupils in the secondary department exceeds 200;
- (b) £175, where the number of pupils in the secondary department does not exceed 200:

Provided that the total amount of such allowances held by an assistant teacher shall not exceed the vice-principal's allowance together with the amount of the special allowance, if any, granted to the vice-principal.

(2) In the case of a vice-principal the special allowance together with the vice-principal's allowance shall not exceed the sum of the principal's allowance and the further allowance or £375 per annum whichever is the less.

(3) A principal shall not be eligible for a special allowance.

**7C.—**(1) Before any special allowance is recognised by the Ministry for the purposes of these Regulations, the school authorities shall furnish to the Ministry a statement showing the extent of the advanced work or the supervisory duties which the teacher is performing and the amount of the special allowance proposed in respect thereof. The payment of a special allowance shall be subject to the Ministry's approval.

(2) A special allowance shall not be approved unless the teacher is:—

- (a) a vice-principal; or
- (b) an assistant teacher, who, to an extent which in the opinion of the Ministry is adequate, is engaged in teaching, or is responsible for the supervision of, advanced work.

7D. The additional annual sum for special allowances for advanced work shall be available and special allowances may be paid in respect of the school year beginning 1st August, 1955 ”.

**Heating, Lighting, Cleaning and Internal Maintenance  
(Amending) Regulations.**

REGULATIONS DATED 20TH DECEMBER, 1956, MADE BY THE MINISTRY OF  
EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND),  
1947 TO 1956.

The Ministry of Education in exercise of the powers conferred upon it by Sections 81 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Heating, Lighting, Cleaning and Internal Maintenance Amending Regulations (Northern Ireland), 1956.

(2) These Regulations shall come into operation on the date hereof.

2. The existing Regulations hereby amended are the Education (Heating, Lighting, Cleaning and Internal Maintenance Contribution) Regulations (Northern Ireland) 1948(a).

3. In paragraph (1) of Regulation 2 of the existing Regulations for the definition of “school” there shall be substituted the following definition:

“ school ” means a voluntary primary school, a voluntary intermediate school, or a special school under voluntary management.’
