Firearms Certificates and Permits

RULES DATED 12TH DECEMBER, 1956, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTIONS 15 AND 18 OF THE FIREARMS ACT, 1920, AS AMENDED BY THE FIREARMS (AMENDMENT) ACT (NORTHERN IRELAND), 1926, AND SECTION THREE OF THE ADMINISTRATIVE AND FINANCIAL PROVISIONS ACT (NORTHERN IRELAND), 1956.

I, The Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs, in exercise of the powers vested in me by Sections 15 and 18 of the Firearms Act, 1920, as amended by the Firearms (Amendment) Act (Northern Ireland), 1926, and Section Three of the Administrative and Financial Provisions Act (Northern Ireland), 1956, and of all other powers thereunto me enabling, do hereby make the following Rules:—

1. The Rules dated 12th February, 1922(a), shall be amended as follows:—

In the form of firearm certificate prescribed in Rule 1, for the words "one year" there shall be substituted the words "three years".

2. The Rules dated 26th June, 1926(b), shall be amended as follows:---

In the form of firearm permit prescribed in Rule 1, for the words "one year" there shall be substituted the words "three years".

3. The Rules dated 22nd March, 1929(c), shall be amended as follows:—

- (a) In Rule 1 the words "The fee for such duplicate Certificate shall be 1/-. and for duplicate Permit 6d." shall be omitted;
- (b) Rule 3 shall cease to have effect.

4. These Rules may be cited as the Firearms (Certificates and Permits) Rules (Northern Ireland), 1956, and shall have effect as from the 1st January, 1957.

Bee Pest Prevention (Amendment) Regulations (Northern Ireland), 1956

REGULATIONS, DATED 13TH JANUARY, 1956, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE BEE PEST PREVENTION ACT (NORTHERN IRELAND), 1945, AS AMENDED BY THE BEE PEST PREVENTION (AMENDMENT) ACT (NORTHERN IRELAND), 1955.

1956. No. 3

The Ministry of Agriculture by virtue and in exercise of the powers vested in it under the Bee Pest Prevention Act (Northern Ireland), 1945(a) as amended by the Bee Pest Prevention (Amendment) Act (Northern Ireland), 1955(b) and of every other power enabling it in that behalf, hereby makes the following Regulations by way of amendment of the Bee Pest Prevention Regulations (Northern Ireland), 1950 and 1955(c).

1. The Bee Pest Prevention (Amendment) Regulations (Northern Ireland), 1955, are hereby revoked as from the first day of February, nineteen hundred and fifty-six.

2. The fee payable under Regulation 10 of the Bee Pest Prevention Regulations (Northern Ireland), 1950, shall be one shilling in respect of each stock.

3. These Regulations shall come into operation on the first day of February, nineteen hundred and fifty-six.

4. These Regulations may be cited as the Bee Pest Prevention (Amendment) Regulations (Northern Ireland), 1956, and these Regulations and the Bee Pest Prevention Regulations (Northern Ireland), 1950, shall be construed as one and may together be cited as the Bee Pest Prevention Regulations (Northern Ireland), 1950 and 1956.
