#### Foyle Area (Rivers Finn and Foyle) (Close Season for Angling) Regulations, 1956

REGULATIONS DATED 28TH MARCH, 1956, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE OF THE REPUBLIC OF IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT, 1952, AND OF THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND), 1952.

The Foyle Fisheries Commission hereinafter referred to as "the Commission", in exercise of its powers under Section 13 of the Foyle Fisheries Act, 1952, and Section 13 of the Foyle Fisheries Act (Northern Ireland), 1952, hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Rivers Finn and Foyle) (Close Season for Angling) Regulations, 1956.
2. So much of any bye-law or regulation now in force as governs the Annual Close Season for angling in the waters described in the Schedule hereto is hereby revoked.
3. It is hereby prescribed that the Annual Close Season for angling in the waters described in the Schedule hereto shall be from the 1st October in any year to the 10th March in the year following, both days inclusive.

The Foyle Fisheries Commission hereinafter referred to as "the Commission" in exercise of its powers under Section 13 of the Foyle Fisheries Act, 1952 and Section 13 of the Foyle Fisheries Act (Northern Ireland), 1952, hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Control of Netting) Regulations, 1956.

2. In these regulations—

the expressions "authorised person" and "Foyle Area" have the respective meanings given to them in the Foyle Fisheries Act, 1952 and the Foyle Fisheries Act (Northern Ireland), 1952.

"fishing station" means any place within the Foyle Area at which a licensee shoots and hauls a draft net and includes the area within a radius of 100 yards from such place.

"licence" means a licence issued by the Commission authorising the use of a particular kind of net in the Foyle Area or in specified waters therein, and "licensee" shall be construed accordingly.
