to the Ministry of Health and Local Government for approval in order to qualify for grant.

The Order also prescribes the rates of grant payable in respect of new farmhouses, approved workers' houses, and reconditioning works, and prescribes the dates before which work must be completed in order to qualify for the rates of grant specified.

The Order also provides, with effect from 1st April, 1957, for the amendment of the limits of net annual value shown in the Third Schedule to the Housing on Farms (Grants) Order (Northern Ireland), 1956, and the Third and Fourth Schedules to the Housing on Farms (Grants) (No. 2) Order (Northern Ireland), 1956, so as to conform to the provisions of the Revalution (Amendment and Consequential Provisions) Act (Northern Ireland), 1957.

## Grants in respect of private houses and houses for letting

The Ministry of Health and Local Government (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by section fifteen of the Housing (No. 2) Act (Northern Ireland), 1946, (in this Order referred to as "the No. 2 Act of 1946") and of every other power it thereunto enabling, hereby makes the following Order:—

# Contributions payable to persons in respect of houses built for letting

1. The contributions payable by a local authority in respect of housing accommodation provided for workers in accordance with the provisions of sub-section (1) of section one of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946, (in this Order referred to as "the Act of 1946") and the sums payable by the Ministry under sub-section (2) of section one of the Act of 1946 to the local authority in respect of those contributions shall, in relation to each new house completed between the first day of January, nineteen hundred and fifty-eight and the thirty-first day of December, nineteen hundred and fifty-eight inclusive, and falling within any one of the four categories mentioned in the first column of the First Schedule to this Order, consist respectively of a single payment of the amount specified opposite such category in the second and third columns of the said Schedule.

Grants payable to persons in respect of houses built for owner-occupation

2. The grant payable by a local authority under sub-section (1) of section six of the No. 2 Act of 1946 and the sum payable by the Ministry under sub-section (2) thereof to the local authority in respect of this grant shall, in relation to each new house completed between the first day of January, nineteen hundred and fifty-eight and the thirty-first day of December, nineteen hundred and fifty-eight inclusive, and falling within any one of the three categories mentioned in the first column of the Second Schedule to this Order, be respectively the amount specified opposite such category in the second and third columns of the said Schedule.

3. This Order may be cited as the Housing (Grants) Order (Northern Ireland), 1957.

## EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

The object of this Order is to extend, in respect of the categories mentioned, the existing rates of grant and of Exchequer payments towards the grants, to houses provided by private persons for letting and owner-occupation, which are completed during the year 1958.

# Rent Restriction Law (Northern Ireland) County Court Rules and Fees Order, 1957

We, the undersigned members of the County Court Rules Committee duly appointed under sub-section (4) of section eighteen of the County Courts Act (Northern Ireland), 1955, do by virtue of the powers vested in us in this behalf by that Act and by the Housing (Miscellaneous Provisions) and Rent Restriction Law (Amendment) Act (Northern Ireland), 1956 (hereinafter referred to as "the Act"), hereby—

- (a) make the Rules in Part I of the Schedule set forth as Rules to be in force in the proceedings under the Act in that Part respectively specified and direct that the Forms in the Appendix to that Part set forth shall have effect for the purposes of those Rules respectively, and
- (b) with the consent of the Ministry of Finance make the Order set forth in Part II of the Schedule prescribing the fees to be paid in respect of those proceedings respectively.
