Notwithstanding anything contained in paragraph 3 the general minimum time rates for workers under 18 years of age are payable to such workers only if they are employed under conditions which, in the circumstances of the case, offer a reasonable prospect of advancement to the general minimum time rate of 2s. $2\frac{1}{2}$ d., per hour. Otherwise the general minimum time rate of 2s. $2\frac{1}{2}$ d. per hour is payable irrespective of age.

This Order, which has effect on and from 25th September, 1957, amends the Sugar Confectionery and Food Preserving Wages Council (Northern Ireland) Wages Regulation Order, 1955 (Order N.I.F. (49)) as amended by the Sugar Confectionery and Food Preserving Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1956 (Order N.I.F. ORDER DATED 7TH AUGUST, 1957, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION FIVE OF THE WILD BIRDS PROTECTION ACT (NORTHERN IRELAND), 1931.

Whereas under Section Five of the Wild Birds Protection Act (Northern Ireland), 1931, (hereinafter referred to as "the Act") I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs, may by order direct that the Act shall apply to any bird excepted from classification for special protection under the Act as if such bird were included for such classification, and specify the Category under which such bird shall be classified:

And whereas under sub-section (1) of Section Sixteen of the Act I am also empowered to prescribe from time to time by order the time of special protection for any bird not specially protected in the First Schedule to the Act:

And whereas representations have been made to me that special protection should be given to geese (Barnacle and Brent).

And whereas Notice was duly given by me on the 1st July, 1957, in accordance with the provisions of sub-section (6) of Section Sixteen of the Act of my intention to make such an Order and the purport thereof:

And whereas no objections were received by me to the making of such Order:

Now, therefore, I, the Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs, hereby order and direct:

- 1. That geese (Barnacle and Brent) shall be classified under the Act as being in Category 1 and the eggs and nests of such birds shall be deemed to be protected at all times during the operation of this Order.
- 2. This Order may be cited as the Wild Birds Protection (Barnacle and Brent Geese) Order (Northern Ireland), 1957, and shall remain in force for a period of three years from the 8th day of August, 1957, unless sooner varied or revoked.
