Short title and commencement

1. These Regulations may be cited as the Sale of Cream Regulations (Northern Ireland) 1957 and shall come into effect on the 5th day of August, 1957.

Standards of quality of cream sold for human consumption

2. The standards of quality to which all cream sold or offered or exposed for sale for human consumption is required to conform shall be as follows:—

- (a) where the cream is described as "double cream" or "thick cream" or by any use of the word "cream" other than being described as "whipping cream" or as "single cream", it shall contain not less than 48 per cent. by weight of milk fat;
- (b) where the cream is described as "whipping cream", it shall contain not less than 35 per cent. by weight of milk fat; and
- (c) where the cream is described as "single cream" it shall contain not less than 18 per cent. by weight of milk fat.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport).

The Regulations prescribe minimum standards to which cream sold for human consumption in Northern Ireland must conform.

The Ministry of Home Affairs in exercise of the powers vested in it by Sections Two, Three and Eight of the Criminal Injuries Act (Northern Ireland), 1957 (hereinafter referred to as the "Act of 1957"), hereby makes the following Regulations:—

1. In an application for compensation under Section Two of the Act of 1957, there shall be substituted for the document in the form set out in the First Schedule to the Act of 1957 a document in the form set out in the First Schedule to these Regulations.

CRIMINAL INJURIES

2. In an application for compensation under Section Three of the Act of 1957, there shall be substituted for the document in the form set out in the First Schedule to the Act of 1957 a document in the form set out in the Second Schedule to these Regulations.

3. The document to be produced by a County Council under Section Eight of the Act of 1957 shall, where the compensation has been paid—

- (a) under the enactment referred to in sub-paragraph (i) of paragraph (a) of Section Eight of the 1957 Act, be in the form set out in the First Schedule to these Regulations;
- (b) under the enactments referred to in sub-paragraph (ii) of paragraph (a) of Section Eight of the Act of 1957, be in the form set out in the Second Schedule to these Regulations.

4. These Regulations may be cited as the Criminal Injuries (Certificates of Inspector General) Regulations (Northern Ireland), 1957, and shall come into operation on the 16th day of August, 1957.
