Whereas it is provided by sub-section (1) of section five of the Health Service Contributions Act (Northern Ireland), 1957 that in that Act "the appointed day" means such day as the Minister of Health and Local Government may by order appoint.

Now, therefore, I, the Right Honourable John Lawson Ormrod Andrews, Minister of Health and Local Government, do hereby order as follows:—

The appointed day, within the meaning of the Health Service Contributions Act (Northern Ireland), 1957, shall be the second day of September, one thousand nine hundred and fifty-seven.

This Order may be cited as the Health Service Contributions (Appointed Day) Order (Northern Ireland), 1957.

The Ministry of Health and Local Government, in exercise of the powers conferred on it by sub-section 7 of section 3 of the Health Service Contributions Act (Northern Ireland), 1957(a), hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Health Services (Employers of Mariners Contributions) Regulations (Northern Ireland), 1957, and shall come into operation on the second day of September, 1957.
- 2. In these regulations, the expressions "British ship" and "foreign-going ship" have the same meaning as in the National Insurance (Mariners) Regulations (Northern Ireland), 1948(b), and the expression "mariner" means a person who is employed under a contract of service either as master or as member of the crew of any ship or vessel.
- 3. Where a mariner neither domiciled nor having a place of residence in the United Kingdom is employed as master or as member of the crew of a British ship being a foreign-going ship, the employer shall be excepted from liability to pay Health Service contributions in respect of that employment.
- 4. Where a mariner domiciled or having a place of residence in the United Kingdom is employed as master or as member of the crew of any foreign-going ship, the weekly rate of the employer's Health Service contribution payable in accordance with section 1 of, and the first schedule to the Health Service Contributions Act (Northern Ireland), 1957, in respect of that employment shall be reduced by twopence.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations exempt employers of mariners (as defined) from the payment of Health Service contributions where the mariners are not domiciled or resident in the United Kingdom and are employed on British foreign-going ships. The regulations also reduce by twopence the employer's contribution, which would otherwise be threepence halfpenny, in the case of mariners who are domiciled or resident in the United Kingdom and are employed on foreign-going ships.

- 1. These Regulations may be cited as the Health Services (General Dental Services Fees) (Amendment) Regulations (Northern Ireland), 1957, and shall come into force on the 1st May, 1957.
- 2. The Schedule hereto shall be substituted for the Schedule to the Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948(a):

Provided that, as regards any course of treatment in pursuance of an estimate or any variation thereof or addition thereto, where the acceptance of the patient took place before the 1st May, 1957, the Scale of Fees in force immediately prior to that date shall continue to apply.
