

"The General Scheme" means the General Scheme under the provisions of Sub-Section (i) of Section 28 of the Act adopted by the Authority on the thirteenth day of May, one thousand nine hundred and forty-eight and approved by the Ministry by an Order made on the thirty-first day of May, one thousand nine hundred and forty-eight, as modified subsequently by the Authority with the approval of the Ministry.

Whereas it is provided in the Act that the Authority may from time to time after consultation with the Ministry adopt a new General Scheme providing for the modification of the General Scheme for the time being in force.

And whereas the Authority having consulted the Ministry consider that it is proper and expedient to adopt a further new General Scheme providing for the modification of the said General Scheme.

Now, therefore, the Authority in exercise of the powers conferred on them by Sub-Section (4) of Section 28 of the Act as amended hereby adopt the following new General Scheme providing for the modification of the said General Scheme, that is to say:

NEW GENERAL SCHEME

1. The Special Care Management Committee, hereinafter referred to as "The Management Committee," as established pursuant to the new General Scheme made under their common seal by the Authority on the first day of March, one thousand nine hundred and fifty-one and amended by a new General Scheme made under their common seal by the Authority on the twenty-third day of October, one thousand nine hundred and fifty-six, shall manage and control the institution known as Drumarg House, Armagh, Co. Armagh.

2. The said Management Committee shall perform in relation to the said institution the functions referred to in Section 29 of the Act subject to the provisions of any relevant Management Scheme made under that Section.

3. The General Scheme shall be read and shall operate as modified by this new General Scheme.

ORDER, DATED 11TH OCTOBER, 1957, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

Whereas by Order dated 12th April, 1949 (in this Order referred to as "the Principal Order") (a), the Ministry of Health and Local Government (in this Order referred to as "the Ministry") approved of management schemes relating to the hospitals named in the First Schedule thereto subject to certain modifications:

And whereas by Orders dated 30th April, 1949(a) and 3rd June, 1953(b) the Ministry approved new management schemes providing for the modification of the said management schemes:

And whereas the Northern Ireland Hospitals Authority, after consultation with the Ministry, on the 23rd day of July, 1957, adopted a new management scheme providing for the further modification of the said management schemes:

And whereas the Ministry thinks fit to approve of the said new management scheme:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the Health Services Act (Northern Ireland), 1948, and of all other powers enabling it on that behalf, hereby orders as follows:

1. This Order may be cited as the Health Services (Approval of Hospital Management Schemes) Order (Northern Ireland), 1957.
2. The Ministry hereby approves of the management scheme dated 23rd day of July, 1957, and directs that a copy of the management scheme as amended and approved by the Ministry relating to each hospital included in the First Schedule to the Principal Order shall be available at that hospital for inspection by members of the public at all reasonable times.
