of the holes shall be $\frac{5}{16}$ ths of an inch from the binding edge and 1 inch from the top and bottom edges.

Margins: Margins shall be delineated by red lines ruled on both sides parallel to and $1\frac{1}{4}$ inches from the binding edge.

2. These Regulations may be cited as the Registration of Deeds (Nature of Paper) Regulations (Northern Ireland), 1957, and shall come into operation on the 1st March, 1958.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations prescribe the quality, size, etc. of paper to be used for Memorials and Requisitions for Negative Searches in connection with the Registration of Deeds.

RESIDENT MAGISTRATES: SALARIES AND ALLOWANCES

ORDER, DATED 20TH NOVEMBER, 1957, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SUBSECTION (4) OF SECTION SIX OF THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

Whereas by subsection (4) of Section six of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935 (hereinafter referred to as "the Act of 1935") it is provided that the Minister of Home Affairs may, by order, with the concurrence of the Minister of Finance, from time to time prescribe the rates and scales of salaries and allowances to be paid to Resident Magistrates and temporary Resident Magistrates appointed under the Act of 1935:

Now, therefore, I, The Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred upon me by the Act of 1935 and of all other powers enabling me in that behalf do hereby order as follows:—

1. The annual salary payable to a Resident Magistrate appointed in and for the county of the City of Belfast shall be two thousand five hundred and fifty pounds and the annual salary payable to every other Resident Magistrate shall be two thousand five hundred pounds. 2. In addition to the salary prescribed in Article 1 hereto a Resident Magistrate shall be entitled to receive the following allowances:—

- (i) Allowances in respect of travelling expenses for journeys undertaken on official duty at the rates and subject to the conditions from time to time prescribed by the Ministry of Finance in respect of civil servants:
- (ii) Subsistence allowance at the rates and subject to the conditions from time to time prescribed by the Ministry of Finance in respect of civil servants:
- (iii) An allowance of eight pounds per annum for postage, stationery and incidental expenses.

3. The salary to be paid to a temporary Resident Magistrate appointed under the provisions of subsection (3) of Section six of the Act of 1935 shall be at the rate of eight and one half guineas for each day upon which he adjudicates as such, together with travelling and subsistence allowances as prescribed in paragraphs (i) and (ii) of Article 2 hereof.

- 4. (i) This Order may be cited as the Resident Magistrates (Salaries and Allowances) Order (Northern Ireland), 1957, and shall have effect as from the 18th April, 1957;
 - (ii) The Resident Magistrates (Salaries and Allowances) Order (Northern Ireland), 1956, is hereby revoked.
