# EXPLANATORY NOTE

## (This Note is not part of the Regulations, but is intended to indicate their general purport.)

The Motor Vehicles (International Motor Insurance Card) (Northern Ireland) Regulations, 1957, require inter alia visitors bringing temporarily into Northern Ireland motor vehicles specified in international motor insurance cards to furnish to registration authorities particulars with respect to the cards and to sign these particulars. These Regulations amend the earlier Regulations by providing for registration authorities to record the particulars as to the cards and by dispensing with the need for visitors to sign these particulars. Some other amendments of a minor or drafting character are also made to the main Regulations.
