EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

Since the coming into operation on the 25th April, 1955, of the Non-Contributory Old Age Pensions (Amendment) Regulations (Northern Ireland), 1955, a person entitled to a pension under the Old Age Pensions Act (Northern Ireland), 1936, has had the weekly rate of his pension adjusted for a period during which he was undergoing free of charge medical or other treatment as an in-patient in a hospital or similar institution so that it should not exceed seven shillings and sixpence. These regulations amend the principal regulations by increasing the maximum weekly rate of pension during such a period to ten shillings. The provision of the principal regulations that in certain circumstances adjustment shall not take place until the pensioner has undergone treatment for fifty-six continuous days is left unchanged.

Returning Officers' Fees and Charges

REGULATIONS, DATED 31ST DECEMBER, 1957, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTIONS FORTY AND FIFTY-FOUR OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

The Ministry of Home Affairs (hereinafter referred to as "the Ministry") in exercise of the powers conferred upon it by Sections Forty and Fifty-four of the Elections and Franchise Act (Northern Ireland), 1946, and of every other power it thereunto enabling, and with the concurrence of the Ministry of Finance, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Electoral (Parliamentary Returning Officers' Charges) Regulations (Northern Ireland), 1957.
- 2. The Returning Officer at any election of a member to serve in the House of Commons of Northern Ireland shall, in respect of the conduct of such election, be entitled to receive as remuneration for his own services the fees specified in that behalf in Section A of the Schedule and to his reasonable charges for any expenses properly incurred by him not exceeding the sums specified in that behalf in Section B of the said Schedule, provided that the charges for disbursements shall in no case exceed the sums actually and necessarily paid or payable.
- 3. The scale of fees and charges prescribed by these Regulations shall apply to all elections to the Parliament of Northern Ireland (other than elections of members for the Queen's University constituency) conducted after the 30th November, 1957.
- 4. The Returning Officer shall, for the purpose of payment to him of such fees and expenses, render to the Ministry accounts thereof in the manner and form and at such times as the Ministry may, with the concurrence of the Ministry of Finance, from time to time direct.
- 5. The Electoral (Parliamentary Returning Officers' Charges) Regulations (Northern Ireland), 1946, are hereby revoked.

REGULATIONS, DATED 25TH NOVEMBER, 1957, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER PARAGRAPH 7 OF THE SECOND SCHEDULE TO THE PENSIONS (INCREASE) ACT (NORTHERN IRELAND), 1956.

In exercise of the powers conferred upon it by paragraph 7 of the Second Schedule to the Pensions (Increase) Act (Northern Ireland), 1956(a), the Ministry of Home Affairs, with the consent of the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Increase of Pensions (Modification) Regulations (Northern Ireland), 1957.
- (2) These Regulations shall come into operation on the sixteenth day of December, 1957, and shall take effect as from the first day of April, 1956.
 - 2. In these Regulations—
 - (a) the expression "the Act" means the Pensions (Increase) Act (Northern Ireland), 1956; and
 - (b) the expression "police pension" means such a pension as is referred to in paragraph 3 of Part I of the First Schedule to the Act.
 - 3. In relation to a police pension—
 - (a) sub-section (1) of section one of the Act and paragraph 2 of the Second Schedule thereto shall have effect as if
