EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to ... indicate its general purport.)

Under the Order in Council of 6th August, 1942, it is prohibited to manufacture, keep, convey or sell acetylene compressed to over nine pounds per square inch above atmospheric pressure, subject to an exception (amongst others) that acetylene at pressures of not over twenty-two pounds per square inch above atmospheric pressure may be manufactured and kept on premises, and under conditions, approved by the Minister of Home Affairs. This amendment provides that the apparatus used in the manufacture or keeping shall, whenever required be submitted to tests carried out on behalf of the Minister, and makes a further exception allowing, subject to the same conditions as to approval and tests, the use of acetylene in the production of organic compounds at pressures not over three hundred pounds per square inch above atmospheric pressure and not mixed with air or oxygen.

Whereas at Geneva on the twenty-eighth day of July, nineteen hundred and fifty-one, a Convention relating to the Status of Refugees was agreed between States (which Convention is hereinafter referred to as "the Convention" and certain provisions of which are set out in the First Schedule hereto):

And whereas by Article 43 of the Convention it was provided that the Convention should come into force on the ninetieth day following the day of deposit of the sixth instrument of ratification or accession with the Secretary-General of the United Nations, and that as regards any State ratifying or acceding subsequently the Convention should enter into force on the ninetieth day following the date of deposit by such State of its instrument of ratification or accession:

And whereas the Convention has been ratified or acceded to by the States specified in the first column of the Second Schedule hereto and their instruments of ratification or accession were deposited on the dates respectively specified opposite to those States in the second column of that Schedule and the Convention has accordingly come into operation as regards those States on the dates respectively specified opposite to those States in the third column of that Schedule:

And whereas by section sixty-one of the National Insurance Act (Northern Ireland), 1946(a), as extended by section five of the Family Allowances and National Insurance Act (Northern Ireland), 1956(b), and section eighty-four of the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946(c), it is provided that the Governor of Northern Ireland may, by Order in Council, make provision for modifying or adapting the
