#### EXPLANATORY NOTE

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

The Regulations raise the salary limit at and above which the appointment or dismissal of an officer employed by the Northern Ireland General Health Services Board is subject to the approval of the Ministry.

REGULATIONS DATED 9TH APRIL, 1957, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION FIFTY-SEVEN OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government in exercise of the powers conferred on it by section fifty-seven of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations:—

1. These Regulations may be cited as the Health Services (Northern Ireland Hospitals Authority Officers) (Amendment) Regulations (Northern Ireland), 1957.

2. The Health Services (Northern Ireland Hospitals Authority Officers) Regulations (Northern Ireland), 1948(b), shall be amended as follows—

(1) For Regulation 2 there shall be substituted the following regulation:—

"2. The number of officers of the following classes, that is to say—

(a) registered medical practitioners and dentists;

(b) nurses in a grade above that of ward sister;

(a) S.R. & O. 1948, No. 100.

(b) S.R. & O. 1948, No. 101.

- (c) other whole-time officers whose maximum remuneration is £700 per annum or more; and
- (d) other part-time officers whose remuneration is, having regard to the duties to be performed by them in the service of the Authority, equivalent to a rate of remuneration of £700 per annum or more for a whole-time officer;

and the remuneration and conditions of service of all officers, as determined by the Authority in accordance with the provisions of sub-section (3) of section fifty-seven of the Act, shall be subject to the approval of the Ministry."

(2) In Regulation 3 the figure "£1,000" shall be substituted for the figure "£700" wherever it occurs.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

The original Regulations made in 1948 provided that the numbers of all officers employed by the Northern Ireland Hospitals Authority should be subject to the approval of the Ministry. In the light of experience the numbers requiring the Ministry's approval are being restricted to (a) all medical and dental posts, (b) senior nursing posts and (c) other whole-time posts carrying a salary of £700 per annum or more, or equivalent part-time posts.

The Regulations also raise the salary limit for individual appointments requiring the Ministry's approval from £700 per annum to £1,000 per annum.
