# EXPLANATORY NOTE

## (This note is not part of the Order but is intended to indicate its general purport.)

This Order amends the Black Scab in Potatoes (Northern Ireland) Consolidation Order, 1930. It establishes an area of 40 townlands additional to that already scheduled in the Limavady area in which only varieties of potatoes approved by the Ministry may be planted or grown.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts (Northern Ireland), 1877 to 1934(a), and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:—

#### Citation and Commencement

1. This Order may be cited as the Importation of Plants (Amendment) (Northern Ireland) Order, 1958, and shall come into operation on the seventh day of August, nineteen hundred and fifty-eight, and shall be read as one with the Importation of Plants (Northern Ireland) Order, 1955(b), (hereinafter referred to as "the principal Order"). The principal Order and this Order may be cited together as the Importation of Plants (Northern Ireland) Orders, 1955 and 1958.

Amendment of Article 7 of the principal Order

2. Paragraph (6) of Article 7 of the principal Order is hereby revoked and the following paragraph shall be substituted therefor:—

- "(6) Raw Apples, Apricots, Greengages, Nectarines, Peaches, Pears and Plums
  - (a) The landing of raw apples grown in the United States of America is prohibited during the period from the 7th day of July to the 15th day of November (both dates inclusive) in any year unless they are of one or more of the following grades as recognised by the Department of Agriculture of the United States of America, namely, "U.S. Fancy", "U.S. No. 1", "Extra Fancy" and "Fancy".
  - (b) The landing of raw apples, apricots, greengages, nectarines, peaches, pears or plums grown in any European country except Belgium, Denmark, Finland, Luxembourg, Norway, Sweden, and the Netherlands is prohibited unless each consignment has been examined by an authorised officer of the Phytopathological Service of the country in which the fruit was grown and found by him to be free from San José scale (Quadraspidiotus perniciosus Comst.) and substantially free from all species of Lepidoptera, including Oriental Fruit Moth (Laspeyresia molesta (Busk))".
