EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations amend the Health Services (Employers of Mariners Contributions) Regulations (Northern Ireland), 1957, following the passing of the Health Service Contributions Act (Northern Ireland), 1958. They have the effect of increasing by a penny to twopence halfpenny the existing employer's contribution in the case of mariners who are domiciled or resident in the United Kingdom and are employed on foreign-going ships.

Appointment of Specialists

REGULATIONS, DATED 8TH AUGUST, 1958, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACTS (NORTHERN IRELAND), 1948 TO 1958.

The Ministry of Health and Local Government in exercise of the powers conferred upon it by Section fifty-seven of the Health Services Act (Northern Ireland), 1948, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1. These Regulations may be cited as the Health Services (Appointment of Specialists) Regulations (Northern Ireland), 1958.

2. These Regulations apply to the appointment by the Northern Ireland Hospitals Authority (hereinafter referred to as "the Authority") of any medical or dental officer whether whole-time or part-time to the post of consultant or senior hospital medical officer or senior hospital dental officer, not being the appointment of persons belonging to any of the following classes:—

- (a) persons to be appointed jointly by the Authority and the Queen's University of Belfast to whole-time posts involving both teaching and hospital duties;
- (b) persons who will receive no remuneration for their hospital appointments;
- (c) persons to be appointed to the staff of a hospital primarily for the purpose of undertaking research;
- (d) persons to be appointed to posts expressly limited, with the approval of the Ministry, as regards their duration.

3. For the purpose of these Regulations an Advisory Appointments Panel shall be constituted by the Authority on the occasion of each vacancy in an office, other than an office which the Authority propose to fill by the variation of the contract of an existing consultant or senior hospital medical officer or senior hospital dental officer. A vacancy in an office shall for the purpose of these regulations include a new office which it is proposed to fill. Where the office involves teaching duties the Panel shall be constituted in accordance with the provisions of Part I of the Schedule hereto. Where the office does not involve teaching duties the Panel shall be constituted in accordance with the provisions of Part II of the Schedule.

4. The Authority shall advertise any vacancy in an office which it is proposed to fill and shall allow not less than one month for the receipt of applications for the appointment.

5. The Authority shall refer to the Advisory Appointments Panel all applications received before the closing date specified in the advertisement and may so refer any application received after that date where the Authority is satisfied that such application could not have been submitted before that date for reasons beyond the control of the applicant. The Advisory Appointments Panel shall consider all applications referred by the Authority and may interview suitable persons, with a view to submitting to the Authority a short list of persons considered by them to be suitable for appointment, together with any comments they may wish to make. If the Authority so request, the Panel shall place the persons on the short list in the order in which they consider them most suitable. If the Panel are of opinion that none of the applicants is suitable for the appointment they shall so inform the Authority.

6. No appointment shall be made by the Authority except from applicants selected in the manner aforesaid.

7. The Authority may make to the members of an Advisory Appointments Panel payments in respect of travelling and

subsistence expenses in accordance with the scales and subject to the conditions laid down in the Health Services (Travelling Expenses) Regulations (Northern Ireland), 1953 (a).

SCHEDULE

PART I

Posts involving Teaching Duties

The Advisory Appointments Panel shall be constituted as follows :—

- (a) Five persons nominated by the Authority, one of whom shall be a consultant specialising in the branch of medicine or dentistry concerned outside Northern Ireland;
- (b) two persons nominated by the Queen's University of Belfast;
- (c) three persons nominated by the Hospital Management Committee concerned, or if two or more Hospital Management Committees are concerned by those Committees jointly. One of the persons shall be, where a medical appointment is to be made, a member of the medical staff of the hospital or one of the hospitals concerned, or where a dental appointment is to be made, a member of the dental staff (if any) of the hospital or hospitals;
- (d) two persons nominated by such organisation as appears to the Authority to be representative of the class of specialists concerned.

PART II

Posts not involving Teaching Duties

The Advisory Appointments Panel shall be constituted as follows :—

- (a) Five persons nominated by the Authority, one of whom shall be a consultant specialising in the branch of medicine or dentistry concerned outside Northern Ireland;
- (b) Three persons nominated by the Hospital Management Committee concerned, or if two or more Hospital Management Committees are concerned by those Committees jointly. One of the persons shall be, where a medical appointment is to be made, a member of the medical staff of the hospital or one of the hospitals concerned, or where a dental appointment is to be made, a member of the dental staff (if any) of the hospital or hospitals;
- (c) two persons nominated by such organisation as appears to the Authority to be representative of the class of specialists concerned.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

The Regulations make provision with respect to the procedure to be followed by the Northern Ireland Hospitals Authority in appointing certain medical and dental specialists. They require the advertising of the posts and provide for the setting up of an Advisory Appointments Panel to select and submit to the Authority the names of suitable applicants.

The Ministry of Health and Local Government, in exercise of the powers conferred on it by section eleven of the Health Services Act (Northern Ireland), 1948, and in conjunction with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Health Services (General Dental Services Fees) (Amendment) Regulations (Northern Ireland), 1958, and shall come into operation on the 1st January, 1959.

2. The Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948(a), shall be amended as follows:—

In Regulation 7 for the words "first day of May, 1957" there shall be substituted the words "first day of January, 1959" and for the words "2·6 per cent." there shall be substituted the words "4·7 per cent."
