Airmen Amendment Regulations (Northern Ireland), 1958

REGULATIONS, DATED 29TH JULY, 1958, MADE BY THE NATIONAL INSURANCE JOINT AUTHORITY AND THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

The National Insurance Joint Authority, in exercise of powers conferred by section 10(2)(a)(ii) of the National Insurance Act (Northern Ireland), 1946(a), and the Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance, in exercise of powers conferred by section 28 of that Act, and of all other powers enabling them in that behalf, hereby make the following regulations:—

Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Airmen) Amendment Regulations (Northern Ireland), 1958, shall be read as one with the National Insurance (Airmen) Regulations (Northern Ireland), 1948(a), (hereinafter referred to as "the principal regulations") and shall come into operation on the 11th August, 1958.

Amendment of regulation 4 of the principal regulations

- 2. For regulation 4 of the principal regulations, there shall be substituted the following regulation:—
 - "4.—(1) Any person, who is or has been employed as aircrew or who is or has been under contract to travel at his employer's expense for the purpose of commencing such employment, shall not, by reason of his being absent from Northern Ireland (but subject to the provisions of paragraph (a) of regulation 10 of the National Insurance (Unemployment and Sickness Benefit) Regulations (Northern Ireland), 1948), be disqualified on any day for receiving sickness benefit, if, in respect of such day or days, he has been left outside Northern Ireland, or his employment has been terminated or he has not commenced such employment—
 - (a) on account of any hurt or injury received, or any illness suffered, by him while so employed or under contract so to travel; or
 - (b) in consequence of any action taken, while he is or was so employed or under contract so to travel, for the purpose of preventing infection.
 - (2) Where by virtue of this regulation a person is not disqualified on any day for receiving sickness benefit, although absent from Northern Ireland, he shall be deemed to be incapable of work by reason of some specific disease or bodily or mental disablement on any such day.".

Regulation 5 of the principal regulations ceasing to have effect

3. Regulation 5 of the principal regulations (which provides for the suspension of payment of benefit to airmen whilst absent from Northern Ireland) shall cease to have effect.

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations amend the National Insurance (Airmen) Regulations (Northern Ireland), 1948, by extending the provisions of those regulations, which make exceptions from disqualification for receipt of sickness benefit by reason of absence from Northern Ireland, and by applying those provisions to certain persons who travel to commence employment as aircrew abroad. They provide that the provisions of those regulations which suspend payment of benefit to airmen while absent from Northern Ireland shall cease to have effect. The remaining alterations are of a minor and consequential character.
