Local Education Authorities: Appointment and Dismissal of Officers

REGULATIONS DATED 26TH AUGUST, 1958, MADE BY THE MINISTRY OF EDUCATION, UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1956.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 89 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Regulations respecting the Appointment and Dismissal of Officers of Local Education Authorities (Northern Ireland), 1958.
- 2. None of the officers hereinafter in this Regulation specified shall be appointed or removed from office by a Local Education Authority, nor shall their salaries or remuneration be fixed or altered, without the concurrence of the Ministry, that is to say:—
 - (i) Chief Education Officer.
 - (ii) An officer, by whatever name or title designated, appointed as deputy to a Chief Education Officer.
 - (iii) An officer with the designation Assistant Education Officer or Administrative Officer or Administrative Assistant or similar title appointed to perform higher administrative duties.
 - (iv) Accountant.
 - (v) School Architect.
 - (vi) Educational Psychologist.
 - (vii) Specialist Adviser on or Organiser of a particular subject or subjects of school instruction.
 - (viii) School Meals Organiser or Assistant School Meals Organiser.
 - (ix) Chief School Welfare (or School Attendance) Officer.
 - , (x) Youth Advisory Organiser or Officer.
 - (xi) Any other officer who is required as a condition of his appointment to possess special academic, technical or professional qualifications.
 - (xii) Any other officer whose remuneration is at the rate of £1,000 per annum or more or who is placed on a scale of salary the maximum of which is at the rate of £1,000 per annum or more.
- 3. The foregoing provisions of these Regulations shall be without prejudice to the provisions of any other regulations duly made and from time to time in force and they shall not apply to teachers whose appointment, removal and conditions of service are the subject of other rules and regulations.

- 4. The said concurrence to the appointment and removal and to the fixing and alteration of the remuneration of every officer as hereinbefore specified shall be signified by the Ministry in writing.
- 5. All officers to whom Regulation 2 of these Regulations applies shall be appointed under a written contract which shall specify the terms of their employment and the nature of their duties.
- 6. The Regulations respecting the Appointment and Dismissal of Officers of Education Authorities (Northern Ireland), 1953, dated 19th June, 1953(a), are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide that such officers of a local education authority as prescribed in Regulation 2 shall not be appointed or removed from office, nor shall their salaries or remuneration be fixed or altered, without the concurrence of the Ministry.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 94 and 112 of the Education Act (Northern Ireland), 1947 (hereinafter referred to as "the Act"), and of all other powers enabling it in that behalf, and after consultation with the Ministry of Health and Local Government, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Local Education Authorities (Borrowing) Regulations (Northern Ireland), 1958.
- 2.—(1) These Regulations shall come into operation on 1st November, 1958.
