EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations provide for the division of the school year (in primary schools) into three terms.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance hereby makes the following Regulations:-

- 1.—(1) These Regulations may be cited as the Primary Schools (General) (Amending) (No. 2) Regulations (Northern Ireland). 1958.
- (2) The existing Regulations hereby amended are the Primary Schools (General) Regulations (Northern Ireland), 1949(a), as amended by the Primary Schools (General) (Amending) Regulations (Northern Ireland), 1950(b), 1952(c), 1953(d), 1957(e) (No. 2), 1957(f) and 1958(g).
- 2. The following Regulation shall be substituted for Regulation 18 of the existing Regulations:—
 - "18.—(1) Subject to the provisions of paragraph (2) and of Regulations 19 to 26, the maximum number of teachers in a school, in addition to a Principal, in respect of whose salaries grant may be paid by the Ministry, shall be as follows:—

Average daily enrolment of pupils for year ending 31st December

Maximum Number of Assistants (in addition to a Principal) for the year commencing 1st August following

At least 25 but not exceeding 64 pupils

Exceeding 64 but not exceeding 104 pupils

and so on, an extra teacher being allowed for each additional 40 pupils on the roll.

- (2) In addition to the number of teachers authorised under paragraph (1), an assistant teacher may be appointed for each 265 pupils on the average daily enrolment for the year ended 31st December; this will have effect from the 1st August following."
- 3.—(1) In Regulation 19 of the existing Regulations the expression "standard V" shall be replaced by the expression "Primary 7".
- (2) The said Regulation 19 shall be alternative to the provisions of paragraph (2) of Regulation 18 and the school authorities may, subject to the approval of the Ministry, make appointments in accordance with whichever of the two alternative sets of provisions is more favourable to the staffing of the school.
